In regard to any other alleged incident regarding this offender, in approximately March 1984, allegations of rumours concerning John Farrell using inappropriate language and suggestion of a sexual nature were made by a parent to Monsignor F Ryan who was the Parish Priest of Moree NSW at the time. The allegations were about inappropriate language and no allegations re John Farrell of a behavioural nature were made at that time.
