## **3 MASS OF THE HOLY SPIRIT**

This Mass was concelebrated in the Chapel of the Sacred Heart Monastery, Kensington, N.S.W. at 7.00 am on Friday 26 April 1991. His Eminence, Cardinal Clancy, the Conference President, was the principal celebrant.

## **4 OPENING OF THE MEETING**

The meeting began after recitation of "Prayer During The Day" at 9.15 am on Friday 26 April 1991.

The President, Cardinal Clancy, welcomed in this session the Apostolic Pro-Nuncio, Archbishop F. Brambilla, the Observers and the Press Officer, Miss M. Newport.

## **5 MESSAGE TO THE HOLY FATHER**

The Conference sent this Message to His Holiness John Paul II:

"THE BISHOPS OF AUSTRALIA, ASSEMBLED IN SYDNEY, SEND FRATERNAL GREETINGS TO THE HOLY FATHER, AFFIRM SOLIDARITY WITH HIM, PLEDGE LOYALTY AND DEVOTION.

THEY EXPRESS GRATITUDE FOR HIS CALL TO THE CATHOLIC FAMILY FOR THE CONTINUING PROMOTION OF AND GENEROUS SUPPORT FOR VOCATIONS TO THE PRIESTHOOD AND TO THE CONSECRATED LIFE.

DURING THE CENTENARY OF THE MEMORABLE LETTER OF HIS ILLUSTRIOUS PREDECESSOR, POPE LEO XIII, "RERUM NOVARUM", THE BISHOPS UNDERTAKE TO RESPOND TO THE HOLY FATHER'S APPEAL FOR THE IMPLEMENTATION OF THE CHURCH'S SOCIAL TEACHINGS.

HUMBLY ASKING FOR THE HOLY FATHER'S APOSTOLIC BLESSING".

The Most Rev Archbishop Angelo Sodano, the Pro-Secretary of State replied:

"THE HOLY FATHER WAS PLEASED TO RECEIVE THE DEVOTED MESSAGE OF ECCLESIAL COMMUNION SENT HIM BY THE AUSTRALIAN BISHOPS MEETING IN PLENARY SESSION IN SYDNEY. OFFERING FERVENT PRAYERS THAT YOUR DELIBERATIONS WILL BE GUIDED BY THE HOLY SPIRIT AND WILL CONFIRM THE CHURCH IN AUSTRALIA IN HER JOYFUL WITNESS TO CHRIST THE RISEN SAVIOUR HIS HOLINESS COMMENDS YOU AND YOUR BROTHER BISHOPS TO THE LOVING INTERCESSION OF MARY MOTHER OF THE CHURCH. AS A PLEDGE OF HEAVENLY FAVOURS HE CORDIALLY IMPARTS THE REQUESTED APOSTOLIC BLESSING".

**8 CONFIRMATION OF MINUTES**

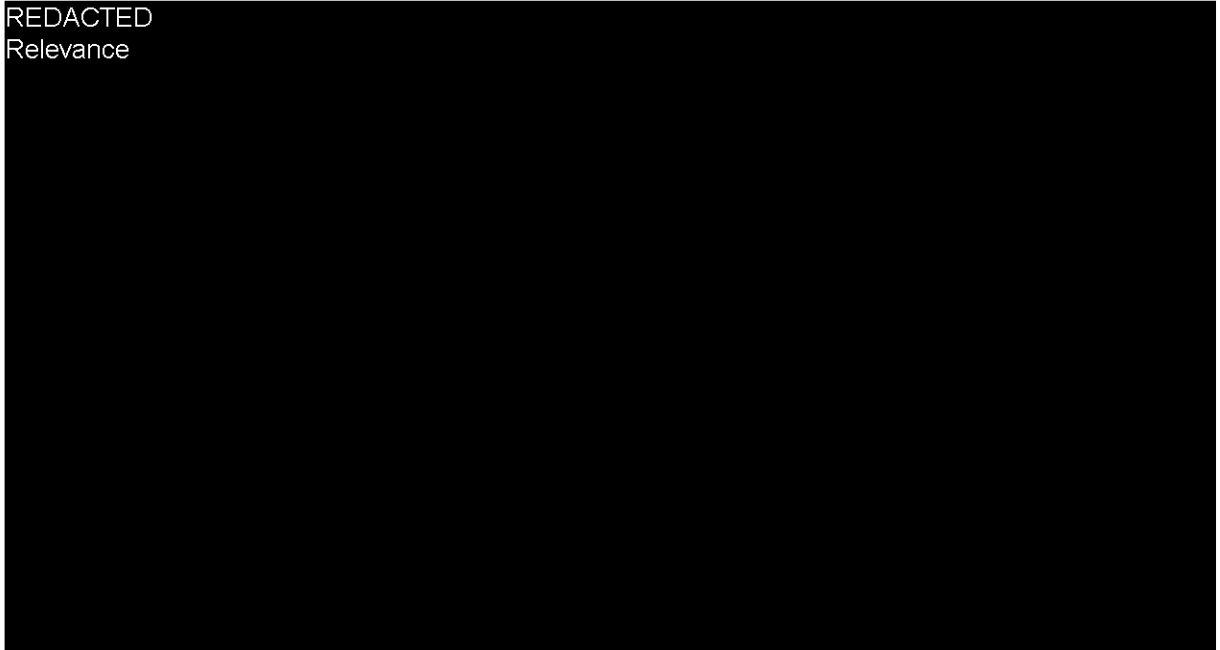
The Minutes of the December 1990 Meeting had been distributed to all members of the Conference. In the inaugural session the following motion was submitted:
