Facts: John Farrell is a retired Catholic Priest. During his Priesthood he was the Parish Priest at St Margaret Mary's, Merrylands Road, Merrylands. The victim CPK lived in the Merrylands area between 1991 and 1993. During that time he became acquainted with Fr. Farrell.
. CPK alleges that during the mentioned years he was sexually assault by Farrell on a number of occasions. The assault involved oral intercourse, both by Farrell upon CPK and by CPK upon Farrell.
. The assaults would take place at the Presbytry

and other locations that Farrell would take CPK to, which included shooting trips away.
. CPK was about 12 years old at the time of the offences. The offences were never reported by CPK as a child.

In 1998 CPK began to demand money from Farrell claiming that he would report the assaults if Farrell did not compensate him. Farrell gave CPK about \$20,000.00 during a number of transactions which involved him both directly handing CPK money, and through transfers from his own account into that held by CPK.

In September, 1998 Farrell reported the matter to Police and CPK was subsequently arrested and charged with twelve counts of Demand Money with Menaces. CPK did not disclose to arresting Police that he had been assaulted by Farrell. He later provided information to investigating Police that he had been assaulted however declined to make a formal statement of complaint.

CPK failed to appear in Court in relation to the matters and a number of Warrants were issued for his arrest.

CPK was arrested at Windsor in 2002 and charged by virtue of the Warrants. He again indicated that he had been assaulted by Farrell however declined to make a formal statement of complaint.

In April, 2003 a statement made by CPK to Mr. Storie, Solicitor where he disclosed certain sexual assaults by Farrell. The statement was lengthy however the dates were non-specific and the actual offences were not described in detail.

Police made contact with CPK in late April, 2003 to arrange a suitable time to record a further statement. CPK indicated that he wished for his Solicitor to be present whilst the statement was obtained.

CPK indicated that he would contact Police with a time that he and Storie could attend to make the statement. No reply was received. Police have attempted to contact CPK on an almost daily basis to pursue the matter however this has been met with a negative result.

Mr Storie, Solicitor indicates that he has also been unable to contact CPK of late and he has missed a number of scheduled meetings.

Police are keen to pursue the matter however a statement from CPK is required before the investigation can continue.

Farrell has been charged with similar offences on two occasions. He has however never been

convicted.
