The attached draft budget is, subject to changes proposed by Bishop-in-Council, intended to be presented to Synod.

Since the last meeting of Bishop in Council:

- The amounts potentially payable in respect of Professional Standards have been adjusted downward (to reflect the likelihood of settlement).
- 2. The loss at Gunundi has been reduced, but it is possible that Gunundi will be a multi-million dollar capital expenditure item in 2008.
- 3. The amounts for Ministry Development and Ordination have (we hope and believe) been finally sorted (!)
- 4. There is now a high degree of veracity as to the amounts of interest due from all potential Diocesan Trust Funds. For the first time proper amounts of income from Funds such as The Ordination Candidates Fund, Ministry Support Fund and others are included.
- 5. I will be seeking from Synod (via a motion) some certainty about being able to be flexible in allowing Bishop-in-Council to review and make "reasonably prudent or necessary adjustments to the Budget as the circumstances dictate." I have no final words as to the proposal, but will seek to reflect the views of the Auditor and Audit Committee.

Ordinances Passed During 2006

The Synod Ordinance requires Bishop-in-Council to report on its exercise of the powers conferred on it by Part IX of the Church Trust Property Ordinance 1934. This largely concerns land sales and leases. Relevant Ordinances passed during the year were:

(Bishop-in-Council again this year did not seek to recover the Five Guinea Fee which it is entitled to recover from the proponents of these Ordinances under Section 41 of *The Church Trust Property Ordinance 1934*!).

Matters Referred to Bishop-in-Council from the Third Session of the Thirty First Synod

Diocesan Trust Funds and Reserves (Diocese)

Bishop-in-Council supported the request from the Registrar early in 2006 to reduce the "the number and thus clutter" of the Trust Accounts and Reserves held on behalf of the Diocese. This has largely been done and the number of Trust Accounts now held in the name of the Diocese has dropped considerably. A typical example were the 10 reasonably minor accounts held for the purpose of "Ordination Candidate's Fund" which are now held in a single Trust Account, for the sole purpose of Ordination Candidates and containing \$160,000, the interest from this can now be properly brought to account in the books of the Diocese as it plans for the future. A number of small accounts held by GDIF for a variety of Diocesan Reserves have also been closed to assist in the management of the Diocesan capital.

North Coast Children's Home

The Diocese was early in the year served with some 450 pages of material from Solicitors acting for 41 potential plaintiffs. The matters complained off were associated with the North Coast Children's Home and included allegations of physical, psychological and sexual abuse. The period covers 1943 - 1981. substantial legal and historical responses were prepared by the Advocate and the Registrar.

The Diocesan Advocate briefed Senior Counsel (Mr Garth Blake SC) to provide advice. The clear advice is that the Church is not legally liable and consequently will maintain its position of resisting and defending the allegations on the basis of:-

- The Statute of Limitations
- No vicarious liability for the illegal acts of a servant or officer
- The Home was not, in law, a diocesan responsibility
- Who in legal terms is the responsible legal entity

However both the pastoral and compassionate side of the church and commercial reality indicates that some amount of money in the form of a care and assistance package will be placed before the claiment's solicitors early in 2007.

The Buttery

The Buttery, located at Binna Burra, was originally started by Rev McNight in the mid 1970s as a place where individuals with drug problems could receive support. Land was acquired for the endeavor through Commonwealth funding and The Buttery was incorporated in XXXX by Synod under the provisions of the *Anglican Church of Australia (Bodies Corporate) Act*. It can be suggested that there has been a drift away from the church in the period since that separate incorporation.

Following approaches to The Buttery about the true owner of the land on which The Buttery now stands an animated conversation took place over a number of months on the issue of the "independent" status of The Buttery. The Board and senior management of the Buttery was robust in its view that it was an autonomous body, whilst the registrar provided advice to Bishop-in-Council that to be incorporated under the "Bodies Corporate Act" the entity had to be an Anglican Church organization. The reality of Bishop-in-Council being able to change the Ordinance and Constitution of The Buttery at any time was also brought to the attention of the Buttery Board.

Following a number of meetings, considerable discussion and heartburn Bishop-in-Council eventually passed the following resolution:

"That Bishop-in-Council note the concerns of The Buttery Board and authorises the Registrar to negotiate with The Buttery Board to achieve;

- a) de-incorporation of the Buttery Board by repeal of the Ordinance;
- b) a hand-over of the subject land at Binna Burra; and
- c) development, with the Board of the Buttery, of an appropriate exit strategy including historical links, time frames, publicity, appointment of the Board members and longer term relationship.
