Dear Stephen & Arthur,

Please find attached for our meeting on Wednesday afternoon the first draft following the discussions at the Special DC on Monday evening.

My proposal is that the Diocesan Council be presented with a track changes version of what the Ordinance will finally look like at its meeting next week. It would be possible for further changes to be recorded on the screen for DC members. I then propose that a resolution along the following lines be proposed to the Diocesan Council ***That the DC approves the proposed amendments to the Professional Standards Ordinance and requests that a Bill for amending Ordinance be drafted to reflect the proposed amendments and that the Committee be authorised to submit the Bill to the Synod for consideration as Bill approved by the Diocesan Council.***

Once we have completed our work tomorrow I will send a further copy to the Deputy Chancellor for his review. I think it is unlikely that we will be in a position to have his comments included in time for the printing of the DC papers but we could send out a further version marked with changes as soon as practical or table it as part of the DC meeting.

I have included work on the Protocols as some matters are best covered in the protocols. It would be my hope that we could approve revised protocols at DC in the next few months with the view to a more concentrated review with the aim of further revising them in November 2013.

I will arrange for Danielle to have printed copies of these documents (in colour) for our meeting.
