

Monday 11 March 2002

Around 1pm? O'ld time PA telephoned home of [BYF] in Perth. Left message on answering machine. Rang back with 2nd message leaving home telephone no.

Called mobile no. and spoke with [REDACTED]. Explained background - Courier Mail story on PA providing reference to court in relation to Daniels' sentencing. PA wanted to be as open and honest as possible. PA writing piece too. PA wanted to make confidential reference to [BYF] telephone call to PA & reporting of abuse. PA concerned that [BYF], who would remain unidentified was happy for that to occur.

[REDACTED] said he would visit [BYF] at his school to see if he was ok about it and call back.

About 30 mins later [REDACTED] called back to say they were both happy with what PA proposed to submit to Courier Mail.

PA agreed to speak with [BYF] again that evening.

c. 7pm O'ld time

[BYF] telephoned PA.

PA inquired as to how [BYF] was. Had been suicidal again last weekend. Just coping.

[BYF] said since conversation on 28/2/02 [BYF] had written to Bp. of Tasmania and informed him of abuse by Daniels + Hawksby.

That day had rec'd letter from John Harrower offering support & counselling, advising a no. he could call at any time for support, indicating he had appointed 2 assessors to investigate the abuse allegations.

(2) 11/3/02

BYF [redacted] was pleased with the response.

BYF [redacted] also said he had contacted the police in Tasmania. He had been advised that the matters he'd reported were criminal matters notwithstanding his age at the time of the alleged events.

Police invited him to go to local station in Perth and make a statement.

BYF [redacted] had contacted his lawyer who advised him not to go to make statement at this stage unless he wanted to land himself in a protracted legal battle where his own integrity would be questioned.

BYF [redacted] indicated he had decided not to go to police and make a statement at this stage.

PA checked that BYF [redacted] had not finally closed off this option. BYF [redacted] said he hadn't, but wanted to proceed with the Discove of Tasmania investigation first.

PA congratulated BYF [redacted] on the great steps he had taken since last ^{week} PA checked through dates of alleged offences with BYF [redacted]

BYF [redacted] indicated that the

East Devonport Rectory incident of robbed hair occurred around 1979 or 1980.

BYF [redacted] would have been 16 or 17 at the time

Triabunna incident occurred he thought in January 1982. BYF [redacted] would have been around 18 years old.

Benarochy Daniels residence incident occurred before the others. BYF [redacted] thought he was around 17 years old.

PA checked with [BYF] re the conversation between them at the East Devonport Rectory. Was [BYF] trying to tell PA about the Daniels abuse in the Glenarmony residence. [BYF] was clear: No. He had never told anyone about that, not even his wife until much more recently.

PA checked with [BYF] whether it was OK for PA to speak with John Harrower about these matters. [BYF] said it was OK for PA to speak with John Harrower.

PA said he didn't want to put [BYF] under any more pressure or anguish than he was already facing and that if meeting in Perth would do that then perhaps it would be better not to.

[BYF] said he was very chilled at saying 'No.' to things he didn't want to do. Cited several egi re visits with brother and father. Said he did want to meet with PA when PA was in Perth.

PA said wanting to Perth on Thurs 14 March 2002 and would be free that evening.

Arranged to meet in restaurant near city.

[BYF] + [REDACTED] to arrange quiet restaurant where they can talk with PA.

PA to check HB transport + accommodation arrangements and get back to [BYF] Tues 12/3/02
