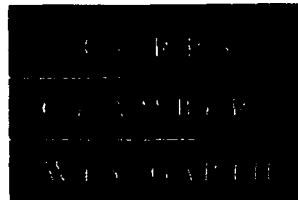

REVEREND R PICKERING

Thank you for your facsimile of 6 April 1994.

When an insurer grants indemnity pursuant to the terms of an insurance policy, the insurer, by way of rights of subrogation, is entitled to conduct the action on behalf of and in the name of the insured. In this case, as CCI is the insurer, and as it has agreed to give indemnity to the Archbishop, it, and its solicitors are entitled to act on behalf of the Archbishop and in his name.

Please do not allow the complete file on Father Pickering to be handed to Dunhill Madden Butler without the writer first seeing it. It would be unwise to advise Dunhill Madden Butler that you are sending the file to us first, because it may well be that there is something in the file that need not go to them.

Please let us have the file as soon as possible for our consideration.
