Dear Br Alexis,

As you know, we are "running hard" to prepare ourselves for the TH facilitation in this matter in Brisbane on 30 March.

You will no doubt send me a copy of Professor Harvey Whiteford's report as soon as it arrives, noting that he was due to see DK on Wednesday 17 March.

In anticipation that the facilitation will also address the claim concerning the person who you have now identified as Br Anthony Hunt, could you please send down to me (and also to Joe) all material which you hold relating to Br Anthony Hunt, noting the following:-

- Has he got any "priors"? If so, please send through the details.
- Please give us his Ministry history.
- You refer in your 3 March email to Joe to "some totally internal matters with the Marist Brothers" in which "Br Anthony Hunt has acknowledged that there were some difficulties in his career and that did include Cairns". Could you please give us the details.
- It might be easiest for us to get those details in a telephone conference with you (which I would record on my side as a confidential record of our discussion, as per my usual practice). If you think that is a good way to proceed, please send me an email to that effect and my secretary (Liz Constable - Tel: (03) 8624 2013 - email: econstable@mrlaw.com.au) will arrange a mutually convenient time for me to phone you for that purpose.
- Are there any facts that we should be aware of which might concern either potential legal liability of the Marist Brothers (relating to Br Anthony Hunt) or indemnity (prior knowledge regarding Br Anthony Hunt)? If so, please provide the details.
- Have you yet spoken to Br Anthony Hunt and does he acknowledge the complaint made by DK (in paragraph 6 of his Statement).
- Do you have a signed copy of that Statement? - the one I have is unsigned and undated.
- Will Br Gerald Burns and Br Andrew Moraghan be attending the TH facilitation with us?
- What does Br Andrew Moraghan say about paragraphs 8 of DK's Statement?
- Have you spoken to Br Rodney about paragraph 11 of DK's Statement and, if so, what does he say about that allegation, and about his knowledge of "the Ross Murrin incident" referred to?
- Is there any other information which Joe Bucci and I should have before the 30 March facilitation?

Thank you for forging such a good relationship with DK, which will no doubt be very helpful in dealing with the matter effectively on 30 March. I look forward, as always, to working with you on that day to resolve the matter on just and equitable terms to all concerned.
