Dear Jodie,

We refer to your email of 22 January 2016 and provide the following information in response to Porters letter of 23 December 2015:

1. The Trustees of the Diocese of Maitland Newcastle owned the school at the relevant time, 1973-1978.
2. This question should be directed to the entity that owned the school.
3. The Principal at the relevant time operated the school to the extent that he employed staff, supervised performance and management of staff on a day to day basis, implemented and supervised the day to day conduct of the school and assumed the responsibility for the care of staff and students. The Principal from 1973 to 1976 was Brother Christopher Wade who resides at [REDACTED] 2013. The Principal in 1977 and 1978 was Brother Alexis Turton who resides at [REDACTED] 2148.
4. The operator of the school was not a corporate entity.
5. The operator of the school was not an unincorporated association. Nonetheless, we provide the following information:

- 1973- 1976 - Br Charles Howard: Br Charles passed away on 13/01/2012; the executor of his estate is Br Jeffrey Crowe of [REDACTED]
