Good afternoon Detective Baxter,

We can confirm that Brother Dominic O'Sullivan was attached to St Mary's Catholic College, Casino between 1978 and 1985. We are now making inquiries to assist you in locating enrollment/class records.

We have no records which indicate that there have been previous complaints made against Brother Dominic

However, Brother Dominic has been charged by Strike Force Georgiana, (Maitland-Newcastle) with a number of sexual assault matters which it is alleged occurred whilst he was a teacher at Marist Brothers Hamilton. There were three complainants alleging a number of sexual assaults at Hamilton. The offences were said to have been committed upon them in the early 1970s. He was transferred from Marist Brothers Hamilton to St Mary's Catholic College, Casino on 1.01.1978.

There was a complaint by a student from St Peter Claver College, Queensland in 1996 of sexual assault by Brother Dominic, where the complainant was interviewed and made a statement to Detective A.A. Bennett at Goodna Police, Queensland on 15.07.1996. Police took no further action.
