Yesterday I spoke with Mr **REDACTED** who is a **REDACTED**. He can be contacted at **REDACTED**. His home telephone number is **REDACTED**, email address is **REDACTED**. **REDACTED** told me that he was a victim of fondling, cuddling and lower level sexual abuse by Brother Dominic and Brother Patrick and physical abuse at the hands of Brother Cashin when he was a student at Marist Brother's Hamilton between 1968 and 1974.

I have passed this information onto Detective Belinda Morris of Newcastle Detectives. **REDACTED** indicated he was willing to assist any police investigation and he might be able to assist with the identity of other victims.

I did not go too deeply into the abuse however he did say Brother Dominic used to fondle him at school.
