**SUMMARY OF ST. ANN'S TASKFORCE MEETING**  
**HELD AT WEST TCE. WEDNESDAY 19<sup>TH</sup> MARCH 2003**

**Present:** Archbishop Wilson, Jane Swift, Sue Cain, Joan Atkinson, Tony Fuller, Pauline Frick, Anne Carolin and Eileen Young.

**Matters Discussed:**

Archbishop Wilson has responded to TF' Fax regarding Brian Hays nomination as replacement for Chris Kourakis

Sue Cain is currently trying to make contact with Kevin Ryan CBC in Wa They have used TH to deal with child migrant cases.

Anne has received information from Loreto regarding student reports. The school has worked on the principle of destroying student files 7 years after they leave school or once they have turned 25. However since the start of the enquiry Loreto has held onto all student files. Consequently the school currently has documentation for some students who left the school prior to 1995. Anne agreed to send a copy of this information to Tony Fuller.

Anne received a letter from LR [redacted] and Family 2 [redacted] informing her that LG [redacted] is currently receiving counseling with Malcolm Robinson in relation to trauma involved with abuse at St. Ann's. Anne said that she would pass on this information to Sue Cain for PS to respond to. She would write letter to the family letting them know that she had done so. Sue Cain said that there were some sensitivities around this family as LS [redacted] was a REDACTED REDACT and may feel uncomfortable about the personal connection in matters relating to his family. Sue and Ann decided to send their correspondence on Friday so that Sue's letter informing that she had taken over as Director of PS arrived at the same time as Anne's correspondence.

Tony Fuller will make contact with Linda Clifford regarding the meeting with REDACTED [redacted]. He is aware of the need for Allan and Jane to reach resolution in relation to Claude's employment future.

Tony will write a summary of the task groups progress to date.

Joan Atkinson suggested that Chris Rann should be invited to the Task Group Meeting on 2/04/03.

Eileen Young said that in light of Anne's appointment she would no longer be attending meetings and thanked everyone for the opportunity to work with the team on a project of such significance Taskgroup members thanked Eileen Young for the valuable role she had played in over the past year.
