Statements of incidents completed by LN and NJ taken by Cathy Black also authorising Pauline Verity to submit to Police Child Exploitation Investigation Unit
The statements are very detailed and include dates and cross references to places and vehicles, the identity of which were later verified.

Support for validity of claim

There is mention of Mother reporting abuse to NG several years previously. A recent report was made to LJ. Described in LH report as "conclusively abused". Jane Swift reports claimant as being "depressed, "acting out of context" "behaviour deteriorated drastically". Abuse of LE was reported to Police.

Support for validity of claim

Abuse reported to LJ. Described in LH report as "conclusively abused". Mrs RED reports MU as one of those sent to Perkins house to enable respite for carer. Statement made by parents to Dooley.

Documentation

Exchange of correspondence with Dooley on file indicates a statement was made but with the request that the document be treated as confidential. A reply was sent confirming this. It is not certain that the statement constitutes a claim against the Archdiocese.
