
Re: FATHER REGINALD DURHAM

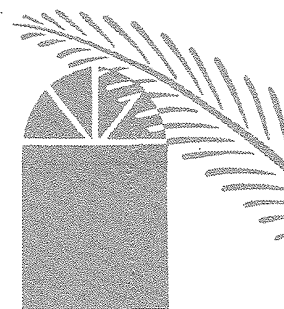
Father Reg has requested that I forward any Account directly to the church.

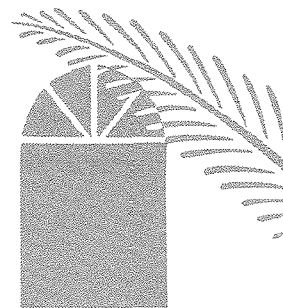
