### CURIA MEETING: 14/7/88

Mr. Exell congratulated on his appointment.

#### SECTION A:

1. PROPERTIES UPDATE: Documents tabled, with comments on:

Doncaster East: a pity to sell at present and break block;

better to hold land and borrow some money.

(Note: D.E.M.F. money needed to buy property in first place. Should it be sold at great profit? Does this constitute

breac of principle re D.E.M.F.?)

Norlane: property to be sold, to permit St. V. de P. hostel

to be built and school re-located.

<u>Kilmore:</u> a) Pyalong: division within community, re re-locating and re-building of school.

b) Wallan: needs watching re possible future development.

N.B.: problems re local solicitor holding titles to several blocks and not producing them.

#### 2. SOUTH MELBOURNE:

Financial situation very precarious, will be more so for his successor. Already a cheque has been stopped.

- seems clear that P.P. has complete freedom re Ryan estate.
- almost certain that parish money goes into Open family organization.
- Mr. Exell to urge P.P. not to sell any property; any sale fraught with danger.
- need to think of next P.P.!

### 3. GREENVALE:

- some 1000 objections have been received to liquor licence.

## 4. GARDENVALE & NATIONAL TRUST:

- Mr. Exell has spoken with Trust representatives, to explain Church's view.

## 5. CENTRAL CATHOLIC LIBRARY:

- Mr. Exell to meet "C.C.L. Friends'" group.
- Jesuits not keen to keep up C.C.L.
- "Friends" should be led to see that bookshop finances library.
- very possibly bookshop could continue, but library would have to go.
- report soon to be completed and presented to archbishop.

## 6. LOAN TO I.C.E.:

- has been done before and could be done again.

who owns I.C.E. properties? Best for purchased property titles to be kept in name of R.C.T.C.

# 7. C.E.O. AUDIT:

- report by Mr. Exell read.
- N.B. C.E.O. Melbourne and C.E.C.V. overlap.
- need to scrutinize all programs carefully.
- present situation causes concern.
- matter of final authority discussed.
- discussion of administration of government grants.
- need to consider matter of separation of melbourne from rest of Victoria.
- Matter to be referred to D.F.C. for discussion.
  - Aspects of audit to be referred to Fr. Doyle for clarification.
  - What budgetary procedure does C.E.O. follow? Why a \$1m surplus one year, a \$1m loss the next?

## 8. CROYDON:

- sale of monastery has fallen through; but plans for re-zoning and sub-dividing is proceeding.
- if I.C.E. wishes it can bid (\$4m plus) but has to make up mind quickly. Probably can't decide in such a short time.

### 9. CLAYTON:

- feeling is that \$150,000 to much to spend on basic repairs.
- probably can be reduced to \$50,000. Mr. Exell to enquire.
- could C.C.C. site be retained, with master plan for total re-building in stages. Some buildings retainable: e.g. Chapel.

## 10 VICTORIAN PARENTS' COUNCIL:

 a non- party political, interdenominational organization, which does have an office on diocesan property.

## 11 GENAZZANO PARENTS:

- seeking more accommodation for country girls, blaming Church authorities for non-support.
- seeking Mr. Exell's help re finding accommodation.

# 12 DOVETON:

- P.P. still keen to build church, despite instruction to desist for five years.

#### 13 BUILDERS:

 builders are not and will not be recommended, though builders' names have been provided.

### 14 COMMISSION FOR JUSTICE, DEVELOPMENT AND PEACE: CHARTER

- Draft no. 2 tabled
- Curia members asked to read and make observations by 21/7/88.

## 15 N.P.I. CLOSURE - IMPLICATIONS FOR PASTORAL FORMATION:

- Clergy seminar (14/7/88) raised pastoral matters re pastoral planning:
  - e.g. young priests say P.P.s block new ideas; P.P.s say they can't introduce new ideas on their own.
- Thus, N.P.I. closure does have serious pastoral implications.
- Some suggestions have been made:
  - Fr. Nicholson, using RENEW.
  - C.C.C. prepared to offer some formation for pastoral workers.
  - Sister Sonia Wagner to spend 1989 researching situation.
  - Fr. Dalton has some ideas.
- Archbishop feels a conference needed, involving above people and others, e.g. Fr. Garland, Fr. Doyle.
  - Fr. Dalton has discussed this with Bishop Connors and asked him to be chairperson.
  - need to avoid overly academic, professional membership.
  - P.P.s need to be on any committee.
  - need also to cater for migrant and religious presence.
  - N.B. if any system/program is to succeed it must have support of P.P.s
  - what are the economics of a system using lay assistants? Can parishes afford them?
  - is there too much emphasis on professional, salaried pastoral assistants?
  - Would permanent diaconate system help? Need it clash with lay pastoral assistant system?

- Need to be wary of power game in area of adult education.
- Need for training at many levels
- need to retain tradition of volunteer workers in parishes.
- N.B. Who should be trained? for what should they be trained?

- perhaps RENEW and R.C.I.A. could run together.
- should R.C.I.A. be optional or mandatory?
