Paul Chris PAVLOU

- **Born in Australia 12th April 1959**
- Greek Cypriot origin.
- Third of 6 children.
- Attended primary school East Burwood/ High school Richmond and Syndal
- Studied Engineering Melbourne's Monash University for one year.
- Completed Diploma of teaching (Primary) at Frankston State College **1981.**
- Majored in physical education and social science.
- Began teaching state primary schools at Hallam and Mount Waverly
- Other members are Greek Orthodox but Paul became a catholic and took up active roles in Catholic affairs.
- Brother Pavlou lived in Salesian establishments at Oakleigh, Lysterfield and Ferntree Gully.
- Taught at St.Joseph's College Ferntree Gully (Salesian Order)
- In his forties accepted by Melbourne Archdiocese as a mature age entrant to priesthood and trained Melbourne seminary.
- Ordained **2004**, worked as assistant priest Croydon (Sacred Heart)
- Late **2005** took up duties at Healesville (St.Brigid's)
- Listed there as administrator or acting priest in charge
- October **2006** complaint arose from concerned mother of 14 yo boy.
- Mother referred to Melbourne Archdiocese Internal Investigation team.
- Complainant interviewed.
- During internal investigation he leaves Healesville after being there for 12 months.
- Was listed as being on sick leave c/o archdiocesan office.
- Mother of complainant then reports matter to police.
- **2007**, Police interview Pavlou and check computer.
- Police retrieve deleted child porn.
- Lilydale CIB issue summons listed for mention **2008** and again **2009**
- **29th June 2009** at Contested hearing pleaded guilty.
- Prosecution amalgamate two counts of indecent acts into one charge.

- Charges performing indecent act with a child under 15 and knowingly possessing child pornography
- Court informed of child porn on computer retrieved by police.
- Defence barrister, Brian Bourke
- Magistrate took into account guilty plea and lack of prospect of any future employment he was trained in.
- Sentenced to 18 months gaol on the indecent act charge but prison was wholly suspended. He was sentenced to a community based order on the child pornography charge.
- Ordered to be on the sex Offenders Registry for 15 years.
- Contact at Lilydale CIU was Leading Senior Const Mark Molloy
- In **2010** was convicted and fined \$400 for failing to alert police when changed address.
- Court also heard that he failed to notify police when he left his accounting job with Basilica Funerals in **2011**.
- Judge warns him that it would be truly exceptional circumstances to avoid gaol should he appear in court again.
- He was supported by his sister in court.
- Court was told that he was engaged to be married in October.
- Between **2010-2012** was attached to a Cricket Association under 15s.
- This was in breach of his obligations as a convicted sex offender
- He was sentenced to three months in gaol for umpiring a junior game and giving false information to police.
- He appealed against the decision and at the County Court changed his plea to guilty to four charges whilst 12 others were withdrawn
- 3 month gaol term wholly suspended for two years.
