
Church Property - Maltravers Road, Ivanhoe (Parish of Heidelberg):

This property is to be transferred to the parish of Ivanhoe and a church is to be erected there by Father Geoghegan. Boundaries between the parishes of Heidelberg and Ivanhoe are to be re-adjusted.

Boundaries:

- (a) The new boundaries submitted by the Parish Priests of Kew and East Kew, resulting from the transfer of the district of North Kew from the parish of Kew to the parish of East Kew, were approved.
- (b) Likewise, the boundaries submitted by Rev. R. Stapleton and Rev. T. Hipwell, O.M.I., resulting from the transfer of Rosebud from the parish of Mornington to the parish of Sorrento, were approved.
- (c) Preston and West Preston: Father Power and Father Fox were appointed to consider the proposal of Father O'Rourke, P.P., West Preston, that that portion of the Preston parish bounded by Bell Street, Gilbert Road, Miller Street and the Merri Creek should be transferred to the parish of West Preston.
