Dear Fr John,

I forward for your records a summary of the pastoral meeting held at the PSO in relation to this matter on Thursday 29 January 2009.

Present at the meeting were: Father John Usher, Michael Salmon, John and Nicola Ellis.

The outcomes of the meeting were as follows:

- Father John will take the necessary steps to organise a pastoral meeting between Cardinal Pell and John Ellis.

- It is anticipated that the meeting will take place in February following the Cardinal's return to full time duties.

- Father John will notify John and Nicola directly of the time, date and place of the meeting with the Cardinal. In this regard it is noted that generally Tuesdays and Wednesdays in February are suitable to John Ellis, although Wednesdays would be his preferred option.

- Father John and Nicola Ellis will also attend the meeting. It was noted that Michael Salmon will attend if specifically requested by John Ellis.

- The meeting may take place in the Chancery or at the Cathedral Presbytery. Father John will clarify in due course.

- The PSO will organise a further pastoral meeting with the Ellis involving Father John and Michael Salmon, and will schedule same for the first convenient date following the meeting with his Eminence.

- John Ellis will continue to forward directly to Father John for his attention his claims for reimbursement for the gap payment in relation to his continuing psychiatric support. It is noted that reimbursement for past out of pocket expenses in this context is now complete, therefore the future claims will relate to his current rather than past treatment plan.
