John Ellis phoned; call taken by MH. He talked about the shock of receiving the letter from the Archbishop on Christmas Eve. He sounded disappointed

rather than angry. He said he understands that there is no point in trying to interview Duggan, but would still like to proceed with the TH process. What this amounts to is that he wants to go ahead with a facilitated meeting with the Archbishop (or his representative). He was mystified by the lack of response since then; it was pointed out that most people have been on annual leave for the past few weeks. MH undertook to alert the Chancery about his concerns and to get back to him **REDACTED** within a day.
