Hi Aidan,

As discussed, I saw AC Adams this morning.

When I saw him today he did not exhibit any at risk behaviours. He is not at risk of self harm or suicidal behaviour. He has a number of protective factors that would stop him from attempting suicide.

He is exhibiting a normal stress reaction due to a number of incidences that he is currently experiencing. However he does not exhibit any depressive tendencies. He appears to be stable and rational.

I believe that he would be able to deal with further stressful information. However we would need some supports in place for after the fact. I will arrange for him to see a psychologist either on Friday or Monday.
