I have received the below SMS message from **CJO** the parent of
CWOFF CJE at 09:49hrs today 25 June 2013.

As follows;

CJE 's dad last night contacted the Duty Officer at Hurstville explained the whole mess, he was shocked Wagga didn't arrange to take statements from the victims!! I'm complaining to the Police Misconduct Unit – the amount of stress this out **CJE** in last night is disgusting! We are making an appointment with Hurstville Detectives at 3pm today where I'm taking **CJE** to do a full statement. I'm not impressed Darren, but had suspicion that Police at Wagga would push back. The worst thing out of this is they may treat each statement as an individual case! I hope the other victims have been informed

I have also forwarded this SMS original to your mobile phone for reference and copy.

This message is part of an ongoing sequence of SMS and phone correspondence between myself and **CJO** over the past 48hrs.
