Sir

I have today reported details of the complaint against LAC(AAFC) Adams to the NSW Police.

Detective Sergeant Sean McWhirter, Auburn Police took details and will be recording the report at Auburn Police Station. He advised that at this stage he did not know who would be dealing with the complaint but thought it may end up at Wagga as the first incident took place there. He advised that it may take a while before anything is done.

I have advised SQNLDR(AAFC) Banfield to cease making any further inquiries into this matter.

The welfare of all parties is being attended to.

CWOFF<sup>CJE</sup> has the support of her mother and Commanding Officer. She has also been supported by the 3WG Psychologist, FLTLT(AAFC) Bev Hargreaves.

FLTLT(AAFC) Hargreaves is a registered clinical psychologist employed by the Department of Education. She specialises in suicide prevention. She believes that CWOFF<sup>CJE</sup> has suitable support and does not believe there is any risk of her self harming.

CWOFF<sup>CJG</sup> has the support of her mother and Commanding Officer. FLTLT(AAFC) Hargreaves has been in contact with her but at this stage I have not

been made aware of any issues. She was assessed last night by SQNLDR(AAFC) Banfield as being distressed. He made the arrangement for FLTLT(AAFC) Hargreaves to immediately contact her last night.

LAC(AAFC) Adams has the support of his Commanding Officer. He has communicated with SQNLDR(AAFC) Banfield who ensured that he was being supported. FLTLT(AAFC) Hargreaves will be speaking to the LAC today to provide support and assess his wellbeing.

I will today forward advice to LAC(AAFC) Adams that the issues raised in the complaint have been reported to the NSW Police for investigation.
