Any and all communications that are sent to CJE in relation to 'ADAMS' matter will be copied into me or sent direct to me and copied to CJE.

We can not allow any communications to be allowed that may compromise this legal matter. We are adults here, and from the connotations in the email to CJE today (below), if Mr Topp has an issue with me, he can most certainly call me. But I would prefer all communications to be kept in writing.
