

12/06/2013: 2005h @ 318 SQN AAFC HQ Sutherland

Present: SQNLDR (AAFC) Sharon O'Donnell {SO'D }, SQNLDR (AAFC) Darren Banfield {DB} [phone], FLTLT (AAFC) David Miskov, Mr [REDACTED], CWOFF [REDACTED] CSGT CJQ

SO'D: Are you aware of the reason I am here to speak with you tonight?

CJQ : *Yes, the face book message*

SO'D: You have notified your CO that a staff member and a cadet have slept together, is that correct?

CJQ : *Yes*

SO'D: Did you bring a print out of the Facebook message that you received?

CJQ : *Yes (supplied two pages)*

SO'D: Could you confirm who sent this to you?

CJQ : *CJE*

SO'D: Does it identify the staff member?

CJQ : *A first name only*

SO'D: I understand that you received a message via Facebook, can you explain your interpretation of that message?

CJQ : *A staff member and female cadets slept together*

SO'D: When you state the staff member and cadet 'slept 'together, what do you mean?

CJQ : *engaged in intercourse*

SO'D: From the information you have been supplied, when did this incident occur?

CJQ : *January promotion course*

SO'D: Were you on the January promotion course?

CJQ : *No I was not on the promotion course*

SO'D: The face book message states a **REDACTED**, do you know who that is?

CJQ : *I believe this is the LAC's wife*

SO'D: Is there a reason you did not notify your CO prior to the 22 May?

CJQ : *I received the face book message the Tuesday prior to the 22nd*

SO'D: Did you have any previous knowledge of the incident?

CJQ : *I had a phone call six days after the promotion course from ^{CJE}*

REDACTED *who stated that she had slept with two people, one in the AAFC and one outside.*

SO'D: Why did you not say anything then?

CJE : *I did not think there was sufficient information and was only here say.*

SO'D: Have you spoken with CWOFF ^{CJE} since this Facebook message was received?

CJQ : *Yes, asked why she had intercourse but can't remember the response as it was some time ago.*

SO'D: Was your conversation formed around the face book message?

CJQ : *Only had one conversation regarding the message, unsure of the date when CWOFF ^{CJE} visited the Squadron.*

DM: approximately 29 May, the week after notification.

SO'D: What was the outcome of the conversation?

CJQ : *We parted ways – the friendship no longer existed*

SO'D: What is your current relationship with CWOFF ^{CJE} ?

CJQ : *Mutual acquaintances*

SO'D: Is/Was she your girlfriend at any point in time?

CJQ *Yes, we broke up in*

SO'D: When did you cease going out together?

CJQ *Broke up in August 2012*

SO'D: Who broke it off with whom?

CJQ *She broke up with me*

SO'D: Why?

CJQ *Don't really know "can't really recall"*

SO'D: Do you think that this was some type of message to make you 'jealous'?

CJQ *Could have been but don't think she would have named other members*

SO'D: Do you have anything further to add? Did you know the other female name?

CJQ *No relationship other than attending junior's course*

SO'D: The face book message only states first name of the staff member?

CJQ *the name of the staff member is LAC Chris Adams*

SO'D: What is your interpretation in the face book message as to CJE being a willing partner?

CJQ *My interpretation is that she was a willing partner; we have not had a conversation to confirm that she was or was not.*

DB: You need to get an understanding of the claim you have made – potentially the staff member and the cadet may be terminated.

CJQ *Yes I do*

DB: If it is proven that the claim is an incorrect claim then it could lead to your termination, Are you aware of that?

CJQ : *Yes I am*

DB: If you have any reason that this may be false or the claim is made with prejudice or you have any further information bring this up to FLTLT Miskov or SQNLDR O'Donnell in the coming days.

CJQ : *Yes*

DB: If you are holding any information or anyone else has knowledge or physical evidence let us know.

CJQ : *No knowledge of anyone else knowing, no physical evidence. I went to CWOFF [REDACTED] as I did not know what I was to do.*

DB: Why would she have notified you of this at all?

CJQ : *We were close prior to January, she told me in confidence*

DB: What are you wanting to seek from lodging this complaint?

CJQ : *I am following my training after doing the SCAP training.*

DB: are you aware of the repercussions?

CJQ : *Yes I am*

SO'D: The other parties have been notified of the allegation. If you have any further information you think of to add then speak with your CO or contact me.

DB: I am just looking to understand why did you lodge the complaint, what are you seeking from lodging the complaint?

CJQ : *Am not looking to seek anything but following training and lodging this as a reportable incident.*

SO'D: I need to notify you of the importance of the confidentiality of the incident, do not discuss any further, if discussed and proven false then there would be repercussions to the parties involved.

CJQ : What if the allegation is made in good faith but is proven false?

DB/SO'D: There would be no repercussions
