For your further information I have just spoken with Air Commodore Green, Director General Cadets Air Force in relation to an update from the NSW police.

Last week Air Commodore Green had written to the NSW Police providing them with information and requesting their urgent action to investigate the allegations and take appropriate action as soon as possible. He has followed up the letter with two phone calls over the past few days.

Air Commodore Green was contacted today by NSW Police and requested to provide additional documentation. As a result of the request, some documents available in Canberra were sent to the NSW Police today.

Additional documents are now being sought from the Australian Air Force Cadet staff and will be sent to the NSW police as soon as they are available. Air Commodore Green expects that getting these additional documents could take a couple of weeks.

For your information, I provided the following information to Ms CJO this afternoon in relation to medical support.
