Sean,

I am keeping this email short, sharp and sweet.

1. Totally inappropriate tone within the email – quite patronising actually.
2. I can only make an assumption that you are not a father (yet) – but if you have peers who have 'step children' remember that they don't have rights to be cared about if their step children are hurt – it appears that is the position of Defence and its quite disgusting and 'inhumane'.
3. I suggest you (AAFC/ADF) take up the matter of 'review of treatment' with our respective Professionals (Clinical Psychologists) who may be able to determine the 'review' of treatment. OR are you a qualified Psychologist/Doctor to make this assumption?
4. I will and will also act in the interests of my daughter NO matter what age she is nor me. How dare you 'push me' away now that CJE is 18 years of age – just remember the offence (and other offences to other victims) occurred whilst under the age of 18 years, in AAFC/ADF 'care', and in the eyes of the law, until the whole matter is dealt with you will communicate with me too! I can not emphasise this in the strongest language.
5. I will not apologise if you got spoken too about responding to my email. But I will note it too 4 weeks for a response, and with nothing realistically in return.

Further to my last, please be advised that I note your concerns however I am unable to provide information pertaining to LAC Adam's personal circumstances since your request breaches privacy law. The other information (if available) is obtainable via a Freedom of Information request. You can make a Freedom of Information request via this link: <http://www.defence.gov.au/FOI/Request.asp>.

With regard to your request for additional counselling support, I appreciate that your husband [REDACTED] is experiencing stress and anxiety and that he is close to CJE. However the Branch position is unchanged and Defence funding is not available for the step-father. He is referred to the resources of NSW Health. The ongoing funding of your counselling and CJE's will also need to be reviewed later this year.

I understand that you are acting sincerely on CJE's behalf however I am concerned as her point of contact that I have yet to hear from CJE regarding any of the questions or issues that you have raised. CJE is no longer a minor and has indicated in her e-mail of 13 August 2014, a preference for direct communication with Cadets Branch (CB-AF) regarding the LAC Adams' matter. As her point of contact at CB-AF, it is remiss of me to continue to rely on third parties however well intentioned to advise me of her concerns. As a result, I will be directing all future correspondence regarding this matter to CJE. A letter has been provided to CJE advising her of this and clarifying my role as her point of contact at CB-AF.

I appreciate that this may not be agreeable to you however I must respect CJE's right to conduct her own affairs as an adult. She is of course welcome to share information with any party she deems suitable.

Today I attended my psychologist again. I have been quite distressed in the past two weeks. My daughter has had University exams this week, with the hope of passing so she can enrol in Nursing at University next year – this is her career choice.

The past 18 mths or so, have not helped, and I am only praying that she 'does' pass so some part of her life can move on happily.

Last week my daughter sent an email to her FLTLT (AAFC) Commanding Officer – Matthew McCarthy of 302SQN, that she requesting 'leave' for the rest of the year. CJE is totally drained, demoralised and 'just had enough'. I have never seen her so disparaged about Cadets. She feels like she is totally letting her squadron down, as they now don't have a Cadet Warrant Officer to assist with the running of the Squadron. She even knows she will be missing out on many ceremonies coming up, all of which she loved and was proud to represent in.

Terry, I am so so disappointed. NO one from ADF/AAFC Seniority have called her, wrote to her, sending on support/wishes or the like.

I am still waiting for the response from Sean Watson too.

Look forward to prompt response. I have been so patient and yet it is not paying off.

Its kind of like the old saying – ‘criminals get the upper hand, while the victims suffer more’.

We hear that LAC Adams is on full pay, suspended, and working a second job, while my daughter and most likely the other victims are suffering in silence, struggling with studies etc, and causing stress to family – as I said indescribable. And we in society call this justice!

Sean,

First of all – Hope you are well now and thank you for your prompt reply. Its unfortunate that Communication is not a strength of AAFC/ADF when it comes to this case. Its unfortunate you had an accident – I hope you are recovery well – but let the powers to be know that it would have been nice to be informed when a Liaison Person is on leave.

I commenced writing this email after your email on the 2<sup>nd</sup> October, but I have had to walk away numerous times, due to the hyper-sensitivity it creates with my emotions.

Jacqueline Hatch in the past has been good in her best capacity in replying ‘politically correct’ responses. I am hoping that you and the AAFC/ADF will be open and transparent with your responses. I have been around Government for far too long and kind of sick of the ‘political niceness’ that is spun.

I have been further privied to information from NSW Police, that in the Court at Newcastle (1<sup>st</sup> October 2014), LAC ADAMS, was further charged with a 3<sup>rd</sup> victim for an incident in Wagga Wagga RAAF Base January 2013 – this was NOT my daughter, my understanding is my daughters matter is being presented in Wagga Wagga Local Court 22<sup>nd</sup> October. So now ADAMS is facing charges to three victims – Damn right disgusting and outrageous!

You would have no idea what I am going through as a mother, nor have any idea how this matter has affected our whole family – No idea! Pain, torment, guilt, disgust are some polite words I can only convey.

Sean, I must ask, that ADF/AAFC must not repeat any publications of any sort on any social media sights – it not only prejudices the matter, but also generates physiological and psychological torment to the victims either direct or through third party questioning.

At the onset of this whole matter, I was 'promised' that a very tight knit circle of persons would be briefed on this matter – well, the network has stretched – a net that Indonesian fishermen would love.

I can not imagine the pain and disgust that the other victims parents/family are going through neither – who knows, more will come forward now that ADAMS grubby face is plastered throughout the media.

The rage and torment that the newspaper article (hard and soft press) has generated with my family is indescribable. I can not speak for CJE's paternal father, my husband (Mr REDACTED of 16 years (14 yrs of CJE's upbringing) is causing 'hell'.

Again – I formerly request that AAFC/ADF fund my husbands counselling/psychological support. The former letter I received has generated so much bitterness towards the AAFC/ADF organisation, I am giving you another chance to meet your duty of care in supporting my husbands needs. Denial is purely inhumane!

Sean I understand you are only the messenger and not the decision maker, but I just want you to fully understand, the sickening affect this whole 'nightmare' has generated is inconceivably traumatic in every sense. This matter has caused so much stress and anxiety for CJE – I am praying to the Gods to let her pass University this year – her life was shattered last year, and this year so far is a real struggle - and there doesn't seem to be much light at the end of the tunnel yet; my own University studies have been so grossly affected, and the cost/investment/time/effort for my Post Graduate Program has been compromised substantially because of this mess – putting it nicely. Not only have my own studies been jeopardised, but also I have not had the determination nor ambition to gain full-time work due to the pressures/stress/anxiety this whole matter is causing.

I am formerly requesting a number of documents to be provided to me.

1. The Signed Consent Form I signed for CJE to attend the AAFC Activity January 2013, Wagga Wagga RAAF Base.
2. A copy of the Policy/s at the time (January 2013) or Briefing Sheet for any 'staff' that was In Charge or Working at the time on course.
3. A copy of the WHS Policy AAFC/ADF at the time January 2013
4. A copy of the Mandatory Reporting Policy/Procedure at the time January 2013
5. Also request, a statement/letter advising me honestly, how was and is LAC ADAMS been managed in terms of NOT being accessible to persons under the age of 18 years whilst at work, since June 2013?

Once again, thank you for getting in touch with me, and I hope your injuries are healing well.
