

STAFF-IN-CONFIDENCE

The following has been brought to my attention on 22 May at 1840hrs.

CSGT ^{CJQ} approached me with a concern and was supported by CWOFF ^{REDACTED} in the interview. CWOFF ^{REDACTED} was not aware of the incident in question, however the CSGT queried as to how to proceed and thus his involvement.

CSGT ^{CJQ} and CWOFF understand that the AAFC member assigned to investigate this claim may interview them in the near future regarding this matter.

FLTLT Miskov: CSGT ^{CJQ} , what matter would you like to raise tonight?

CSGT ^{CJQ} : A staff member sleeping with cadets.

FLTLT Miskov: Is either the staff or cadet from 318SQN?

CSGT ^{CJQ} : No Sir.

FLTLT Miskov: What is the name of the staff member you believe to be doing this?

CSGT ^{CJQ} : LAC Chris Adams

FLTLT Miskov: How did you come about this information?

CSGT ^{CJQ} : I received a message through Facebook.

FLTLT Miskov: Who was the message from?

CSGT ^{CJQ} : CWOFF ^{CJE}

FLTLT Miskov: Do you still have this message?

CSGT ^{CJQ} : Yes I do Sir.

FLTLT Miskov: Do you understand that you will need to retain this message until the matter is resolved?

CSGT^{CJQ} : Yes I do Sir.

FLTLT Miskov: Was the message from CWOFF^{CJE} as either 1) a victim; 2) a willing participant; 3) a witness to an event; or 4) "heard through the grapevine"

CSGT^{CJQ} : A willing participant

FLTLT Miskov: Is there a possibility that this is joke or prank?

CSGT^{CJQ} : I don't believe so Sir.

FLTLT Miskov: Why not?

CSGT^{CJQ} : Because it would seem out of character for the CWOFF.

FLTLT Miskov: Apart from the Facebook message, is there any other evidence you know of?

CSGT^{CJQ} : There was phone call made to me by CWOFF^{CJE}. I received this call in February. She declared that she engaged in sexual activities with the LAC. There were other topics discussed during the call, but nothing pertinent to this alleged fraternisation.

FLTLT Miskov: Why did you not raise this the following Wednesday night after the phone call?

CSGT^{CJQ} : Because I did not believe that it was sufficient evidence.

FLTLT Miskov: When did the alleged fraternisation occur?

CSGT^{CJQ} : On the January Promotion Course.

FLTLT Miskov: Can I view the message?

CSGT^{CJQ} : Yes Sir.

FLTLT Miskov: (reads message) She mentions that LAC Adams wants herself (CWOFF^{CJE}) off course. Is she referring to July 2013?

CSGT^{CJQ} : Yes Sir.

FLTLT Miskov: Who is the other cadet that is mentioned in the message?

CSGT^{CJQ} : CWOFF^{CJG}

FLTLT Miskov: Do you know CWOFF^{CJG} ?

CSGT^{CJQ} : I have met her once or twice, but only know her as an acquaintance.

FLTLT Miskov: So do you consider CWOFF^{CJE} to be 1) an acquaintance; 2) a friend; 3) close friend; or 4) like a 'bestest buddy'?

CSGT^{CJQ} : At the time of the incident, I would have considered us to be 'bestest buddy' as we had previously dated. Now I would consider us to be just friends.

FLTLT Miskov: Is it because of your previous association that leads you to believe that the comments made in the message and on the phone are truthful?

CSGT^{CJQ} : Yes I would say so Sir.

FLTLT Miskov: Is there anything further you wish to add?

CSGT^{CJQ} : No Sir.

FLTLT Miskov: CWOFF **REDACTED**?

CWOFF **REDACTED**: No Sir.
