



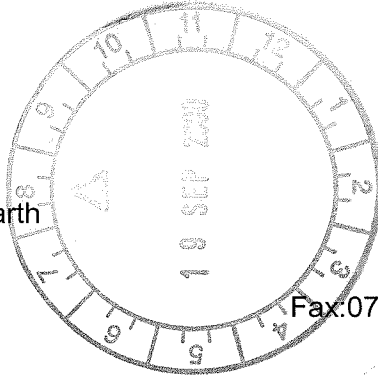

**RE: BRISBANE GRAMMAR SCHOOL/KEVIN LYNCH
 ALLEGATIONS**

We refer to your letter dated 28 August 2000 and note you act for Brisbane Grammar School.

We have been instructed by a number of former students to commence proceedings in court for damages.

The students allege that when attending counselling sessions at the school they were abused by an employee of the school Kevin Lynch.

We have no knowledge of the legal entities and structures that conduct and discharge the duties of schooling or the responsible entity.

We have prepared a claim which we intend to file seeking damages against the Board of Trustees of the Brisbane Grammar School. We believe this to be the responsible entity.

We request you advise the correct legal entity that the claims be made against.

We request your response by 12.00 noon 25 September 2000, so that the appropriate steps can be taken to file the claim.

We put you on notice that should it become necessary in the course of proceedings to amend our client's claim, we will use this letter in a claim for costs against you.
