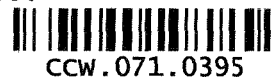

I refer to your facsimile of 8 May in relation to the above and by now I assume you have received a response from HIH.

At this point in time, the only records we are able to find date back to 1984 and the following General Liability Insurers have been advised

- Period:** 1 September 1985 to 1 September 1985
- Primary Underwriter:** Insurance Company of North America (now Cigna – Ace Asia Pacific) \$1,000,000
- Excess Liability Underwriter:** As above – Indemnity \$19,000,000
- Period:** 1 September 1985 to 1 September 1986
- Primary Underwriter:** Cigna Insurance (now Ace Asia Pacific) – Indemnity \$1,000,000
- Excess Layer:** As above – Indemnity \$19,000,000
- Period:** 1 September 1986 to 1 September 1987
- Primary Layer Underwriter:** Royal Insurance, Melbourne Indemnity: \$1,000,000
- Excess Layer Underwriter:** Cigna Insurance – Indemnity \$14,000,000
- 2<sup>nd</sup> Excess Layer Underwriter:** Carlingford Australia Insurance Limited (taken over by CIC Insurance now HIH Insurance) – Indemnity \$5,000,000
- Period:** 1 September 1997 to 1 September 1998
- Primary Underwriter:** Royal Insurance, Melbourne – Indemnity \$1,000,000
- 1<sup>st</sup> Excess Layer Underwriter:** C E Heath, Melbourne – Indemnity \$4,000,000

Unfortunately, we do not have any copies of the actual policy documents and therefore, I would not expect to receive an immediate response from underwriters until at least they have been able to clarify the extent of the cover provided and secondly details of when the alleged offences took place.

We are still endeavouring to locate records prior to 1984, and will advise you of the outcome as soon as we are able.
