## **2015 Training—Education, Policy and Practice**

The JCCV Child Protection Reference Group successfully ran a series of sessions designed to assist organisations to improve their Child Protection Policies and Practices.

We again invite organisations to send up to three representatives, including an **elected Champion** to embed a culture of child protection that aims to keep children and young people safe. The program is divided into five morning sessions that will run sequentially over five months to develop policies and practices in between the formal sessions.

Run by child protection expert, Katherine Levi, the program will provide:

- A clear understanding of child sexual abuse and the indicators;
- The risks to children and young people within organisations;
- The skills required to minimise risks within your organisational context;
- The ability to incorporate prevention strategies into organisational culture; and
- Skills to deal effectively with a suspected, witnessed or alleged incident of abuse.

The program has attracted international interest and was endorsed by the Director of the Quality Improvement Council and Professor Fiona Stanley AC, founding Director of the Telethon Institute for Child Health Research.
