## SUMMARY OF OFFENCE

1) ACCUSED 1: BZC  
 OFFENCE: Producing child exploitation material  
Section 218 Criminal Code  
 INCIDENT NUMBER: 290413170012255  
 VICTIM: N/A

The accused resides at REDACTED with her family, including her 13 year old daughter.

The accused's daughter is affiliated with a dance academy, namely RG Dance Studio. RG Dance Studio was co-owned by Grant Davies (DAVIES), a person recently charged by New South Wales Police (NSWPOL) with numerous child sex offences, including possession of child exploitation material.

During that investigation several other victims throughout Australia were identified through the seizure and analysis of DAVIES' electronic equipment. A large number of images were located depicting children in sexually suggestive poses, including pictures of the accused's daughter who was 12 years of age at the time.

Between 1 March 2013 and 30 April 2013, the accused produced approximately 80 photographs of her daughter in sexually suggestive poses. The images either show her daughter wearing no clothing on her top half of her body, naked from the waist down or only wearing her underwear.

The accused complied with DAVIES' request, distributing those images via social media and mobile phone.

Analysis of those images produced and distributed by the accused revealed that the images are classified as 'Category 1' Child Exploitation Material (images showing semi nudity, underwear and sexually suggestive posing).

On 28 August 2013, the accused participated in an Audio Visual Record of Interview where partial admissions were made stating that she had sent photographs of her daughter to DAVIES but did not believe them to be of a sexual nature.

On 25 October 2013, the accused was charged with the present charges by way of summons.
