FULL FACTS:

INDECENT ASSAULT -Between the mentioned dates, the victim was in the living quarters of the defendant. They were both sitting on the defendant's bed and he commenced tickling the victim. He progressed to under her shirt and then his hand brushed against the victim's breast.

SEXUAL INTERCOURSE WITHOUT CONSENT. -Between the abovementioned dates the victim was again in the defendant's bedroom. The defendant commenced kissing the victim and fondling her breasts. The victim was naked at the time. The defendant then put his finger into the victim's vagina.

INCITE ACT OF INDECENCY- The victim was again in the defendant's bedroom. The victim and a friend got into bed with the defendant and she removed her clothes at his request. The victim moved to the outside of the bed and the defendant put his arm around her and his leg over her leg..

All the above offences occurred whilst the victim was living with her family on an ashram at Mangrove Mountain. The defendant was the main administrator at the farm. The offences occurred when the victim was between the ages of 11 and 15 years.
