- A No, no.
- Q231 You didn't say - - -
- A I told him that I remember something, I remember him, something happening at my house but nothing at all there.
- Q232 What do you recall happening at your house?
- A All I remember is that he stayed over one night and I don't, I have very, very vague recollection of anything else, but I thought when he called up and when he first complained about something, I thought he was referring to an incident that happened at my house, but I don't even recall what actually happened, I just remembered that he was there one night, that's all.
- Q233 And can you tell me which house this was?
- A REDACTED and I don't even think AVB necessarily remembered or recalled that incident, he seemed to only recall, but maybe he did I don't know, he seemed to only recall that particular incident that happened at the camp.
- Q234 So what exactly do you recall about what happened at REDACTED REDACTED
- A Just remember he slept over, I don't remember more details than that.
- Q235 Do you have any recollection of touching him that night?
- A No.
- Q236 Did you indecently assault AVB at any stage?
- A Not to my knowledge, not to my recollection.
- Q237 So you don't remember?
- A I don't remember, correct yes.
- Q238 So earlier in our conversation we spoke about Rabbi Lesches.
- A Mmm Mmm.
- Q239 And him speaking to you.
- A Mmm Mmm.
- Q240 [13:17:00] But you decline to tell me what he actually spoke to you

- about.
- A As I said, no I, I did tell you, he told me that I should simply keep away, that's it.
- Q241 O.K. But he didn't give you a reason as to why you should keep away?
- A I think it was, I think it was, he just told me to keep away, that's what he told me, yeah.
- Q242 Did any other Rabbi speak to you about staying away from other boys?
- A You know I, I, I do have a vague recollection of Rabbi Feldman speaking to me, but I don't really remember much details or anything specific at all.
- Q243 And can you tell me which Rabbi that was?
- A Rabbi Feldman.
- Q244 Is that Rabbi Pinchus Feldman?
- A That's the one, yeah, yeah.
- Q245 What did he say to you?
- A I honestly do not recall the, the conversation, just remember the incident taking place.
- Q246 What context was the conversation in, about?
- A Similar thing to what Rabbi Lesches spoke about, to keep away.
- Q247 From the younger boys?
- A Yes, yes.
- Q248 So I don't know if you've seen, in the media there was a, an email release, which was an email between yourself and Debbie Fox.
- A Mmm Mmm.
- Q249 Can you tell me who Debbie Fox is?
- A She is, she used to work for an organisation called Jewish Family Services in Los Angeles, and she was a, like a counsellor type of person, yeah.
