4. In 2013, I was in Year 10 at The Kings School. In the 2013 season last year, I received a phone call from school (I think it was the deputy headmaster, Mr. Andrew (Akiy) about an incident had been involved in. I was told he could not attend the national championships as a result of an incident the school were investigating. I thought it must have been something serious.

5. At home, I didn't discuss it with Mum too

much. He told me there had been  
 an incident at Cadet Camp where  
 they were working around with  
 condensed milk. This place which I  
 reviewed was in July & August 2013.  
 6. I went to a meeting with D. PARRY  
 and Mrs MAC (Susan MacDonagh) and I was  
 informed <sup>DFE</sup> was suspended for 2  
 weeks whilst the investigation was  
 conducted. Whilst he was suspended,  
 he came to work with me every day.

7. At the conclusion of the 2 week  
 suspension, <sup>DFE</sup> and I went to a meeting  
 with Dr Andrew PARRY and Dr Timothy  
 HAWKES (the Headmaster). It was in August,  
 a couple of weeks before the end of  
 term 3. I picked <sup>DFE</sup> up from home  
 after lunch, and we went to the school  
 for the meeting. It was a weekday.  
 I met with Dr HAWKES and Dr PARRY  
 in Dr HAWKES' office. The office has big  
 glass windows and looks over the  
 Kids' quadrangle.

8. The night prior to the meeting, I  
 spoke with <sup>DFE</sup> at home. I told  
 him he needed to tell me the truth  
 about what happened before I went to  
 this meeting. I wanted to be honest  
 with the school, especially because

is still at the Kings School.

I said, "Was it really condensed milk, or was it something else?"

DFE said, "It was something else"

DFE then told me that he was masturbating and then wiped his hand onto CLC sleeping bag.

9. At the meeting, DFE was in his uniform. Dr HAWKES and Dr PARRY started talking. I interrupted them, and said "I need to tell you something."

DFE told me the truth about what happens if told me that he was masturbating and as a result of masturbating he wiped his hand on CLC sleeping bag." I was very upset and started crying.

10. Dr HAWKES and PARRY thanked me for being so honest. Dr HAWKES spoke harshly to DFE,

told him he'd done a disgusting thing and that he'd embarrassed his family. I offered to withdraw DFE from the school,

which Dr HAWKES accepted. I had the feeling he was intending to expel him.

DFE now goes to a different boys school. The meeting ended fairly quickly after that. EAF
