Police are requesting the information as to ascertain what period the subject was in AUS and on what date they had travelled to England. The individual is subject to historical sexual assault allegations of a serious nature and they have not been recorded in AUS for many years. Information obtained indicates that they travelled to Britain in 1991

Reason for Information Request

The information is relevant as it will assist in furthering the investigation as investigators will know where the individual travelled to and at what they commenced that travel. This is relevant as it may produce circumstantial evidence against the individual for serious sexual assault allegations.

Additional Information:

The birth country is not known however would likely be either Australia or England. The individual is believed to have left AUS sometime near 1991. Police are requesting the information as to ascertain what period the individual was in AUS and on what date they had travelled to England. The individual is subject to historical sexual assault allegations of a serious nature and they have not been recorded in AUS for many years. Information obtained indicates that they travelled to Britain some years ago and may have not returned.

Reason:

The request is being made as to locate an alleged serious sexual assault offender. Information obtained by the Royal Commission into Child Abuse indicates that the individual left AUS the day after the allegations of sexual assault were made. Further evidence by way of a Dr's record indicating anal sexual assault occurred backs up the allegations. OIC is making attempts at locating the individual as to further the investigation.
