1. My full name is AGC, I am 16 years of age, I was born on the RE of REDACTE 1983.

2. I went the Northside Christian College, in Bundoora. The school is a primary and secondary school. I went there from Prep to year six.

3. I think I was in grade three in about 1989, I was about eight years old. My teacher was Ken SANDERLANDS, he took us for things like Maths and English and we would go to other teacher's for music and sport.

4. I remember, that our class was set up with single rows of desks across the room. Ken would walk around the room and check on everyone's work. I remember nearly every day he would come up behind me and put his hands on my chest and rubbed my chest. During the first couple of weeks of the year Ken said, "I love you", and I would say, "I love you too." I remember one day I didn't say I love you, back to him and he took me to the back room and gave me the paddle. The back room was a storage room and where everyone was hit with the paddle. The paddle, was like the old wooden tennis bats. I remember on this day that the window of the back room didn't have any drapes on it. That day was the last day I never said, I love you back to Ken.

5. I remember one day I didn't think I had done anything wrong, and Ken came up to me and whispered to me, could I go into the back room, because we needed to speak. I went into the back room and waited for Ken. He came into the back room and I was leaning over the chair, waiting for the paddle. I moved when he came in, he sat down on the chair and then lifted me onto his lap. Ken then put his hand down the front of my pants and under my jocks and began playing with my penis. This went on for about 30 seconds or something. Ken then told me to go back to my seat in the class room.

6. When Ken would read books to the class one of the girls would sit on his knee while he was reading. There was three main girls that sat on his lap, their names are REDACTED, AGY and REDACTED REDACTED.

7. One day I hadn't finished my maths work, so all the class went out for lunch except for me, RED and Ken. RED was on one side of the room working and I was on the other. He would go back and forth between the two of us. When he came to me, he would check on my work, he was standing behind me and he put his hand down the front of my pants, and under my jocks while helping me work. He played with my penis, by that I mean, he never masturbated me, but fondled my penis and testicles. He then pulled his hand out of my pants and went and helped RED with her work. When I finished my work, he sent me off and RE was left there. RE and I were really slow with our work. I think RE would have been in there most lunch times catching up on her work.

8. During the same year, RE and I were doing something, in the playground. Me and one of the other boys from my class, we went in the class room while Ken was there and made up bull shit and said that RED asked us to have sex and stuff. Then Ken was asking me a whole lot of questions. He said, "Did you wee wee?" I said "Yes". I thought at the time he meant did I piss of her, I didn't, but said I did. Then Ken talked to me, I can't remember where or what the other boy did. Ken was hugging me and rubbing my chest and said, it was alright and that I did good in telling him, then he put his hand down the back of my pants under my jocks and started rubbing my bum. He rubbed my bum for about 30 sec and then I said, "I'm telling Mum". He said, "If you do, when you come back tomorrow, you'll get a paddle and I'll give you a detention." Ken then smack my bum on the outside of my pants and said, "Off you go."

9. In grade five, REDACTED (I'm not sure how to spell his name), and I were at his house, I think it was in REDACTED. I asked him, "Did Ken SANDERLANDS, ever touch your penis or anything?"

He said, "Yeah". We then both told his dad RED. I think RED said, something like, if you told me a bit earlier I could have done something."

10. Ken SANDERLANDS was a very touchie fellie type of person, he was always rubbing our leg and hugging us and he told a lot of the class he loved us. He was always rubbing my chest and grabbing my bum. I know he use to ask a few of the class if they loves him and he would tell them he loved them.
