1. INTRODUCTION

Praise God for the recent meetings with Keith Hounslow. It was good to see people coming to Christ and being touched by the power of God. Let us continue in prayer to cover the new believers with our *shields of faith* as they continue their Christian Walk.

2. KEITH HOUNSLOW AND POWER EVANGELISM

I have spent many hours during this past week with Keith as we outlined the plans and procedures of his commencing ministry with us in 1993. A Contract will be finalised this week and tabled at the meeting on Tuesday night. The following resolutions will need approval: [Final financial figures will be tabled at the Board of Directors meeting.]

"Keith Hounslow be appointed as a member of staff of Northside Christian Centre Inc from 01.02.93 according to the agreed Contract of Employment on an annual remuneration package of \$xx,000 on condition that \$20,000 per annum be paid in Ministry Related Expenses from Northside Christian Centre and \$xx,000 be paid from the income of Power Evangelism. Normal superannuation benefits will apply."

"It is understood that Northside Christian Centre's contribution toward his ministry is also an investment in Missions to release Keith Hounslow's evangelistic gift locally, nationally and internationally."

"Senior Minister and K. Hounslow present a ministry plan to ensure correct stewardship of Northside's financial contribution."

"Power Evangelism be invited to submit an operating budget for its ministry for 1993 to ensure Northside Christian Centre in real terms, is releasing him to his ministry and calling and that his family are adequately cared for."

We have also looked at the possibilities concerning how Power Evangelism can be structured under the incorporation of Northside Christian Centre Inc. The following is shared for your information.

15. COMMONWEALTH BANK PROPOSAL

I have informed the National Australia Bank by letter that we are declining their offer. At your instructions, a meeting with the principals of the Commonwealth Bank has been arranged and a proposal will be presented to them on Tuesday 8th December. I will bring a report to the Board meeting.

16. CARPARK

Pastor John is consulting with the Principal concerning the repairs to the carpark caused by College traffic and painting of the concrete planters and will bring a report to the meeting.

17. RENOVATIONS - FAMILY LIFE CENTRE

I have been working with Raff Marcucci and Keith Hounslow to plan to convert the current Computer Room into an open space working office for Keith Hounslow. I will share the plan with you at the Board meeting for any additional comments you may have concerning this. It will appear the College may require the use of the existing library room a little longer. I will continue to negotiate this with the Principal as it does affect the Rental/Lease Agreement between the Church and College. Praise God that I have been promised around \$5000 to provide this refurbishment - we are living in a time of God's supernatural provision!

18. YOUTH MINISTRIES

I am still consulting with Jim Vaughn concerning two distinct youth groups for 1993 and am giving consideration to his involvement in the 1993 program. I will report more on this at a later date.

19. KEN SANDILANDS

I have requested from Ken, a comprehensive medical report which gives me details of his current visual impairment and his future prognosis. I have also requested a letter of intent which outlines his desire to remain in the teaching system until such a time as his physical impairment would preclude this activity. Further, I have requested the Principal and Deputy Principal to provide me with a performance review, in educational terms, which outlines his effectiveness in his ministry as a teacher at Northside Christian College.

I have received this information and further instructed the Principal to evaluate the Medical Report and table a recommendation by Tuesday 8th December prior to another meeting with Ken to discuss his future. I will bring a report to the Board meeting.
