HER HONOUR:

I vacate each of the sentences I imposed on the last occasion.

Dr Rolleston you are convicted of each count.

In relation to count 3 on the second indictment the count involving Mr

**REDACTED** I sentence you to a term of imprisonment of thirteen months to date from 24 June 2011 and to expire on 23 July 2012.

In relation to count 5 on the second indictment, the count involving Mr

**REDACTED**, and taking into account the matter on the Form 1, I sentence you to a term of imprisonment of fourteen months to date from 24 July 2011 and to expire on 23 September 2012.

In relation to count 7 on the second indictment, the count involving Mr

**AWA**, and taking into account the two matters on the Form 1, I sentence you to a term of imprisonment of fifteen months to date from 24 August 2011 and to expire on 23 November 2012.

In relation to count 2 on the second indictment, the count involving Mr

**AWH** and taking into account the matter on the Form 1, I sentence you to a term of imprisonment of fifteen months to date from 24 September 2011 and to expire on 23 December 2012.

In relation to count 1 on the second indictment, the count involving Mr

, and taking into account the two matters on the Form 1, I sentence you to a term of imprisonment of sixteen months to date from 24 October 2011 and to expire on 23 February 2013.

In relation to count 6 on the second indictment, the count involving Mr **REDACTED** , I sentence you to a term of imprisonment of sixteen months to date from 24 December 2011 and to expire on 23 April 2013.

In relation to count 1 on the first indictment, the count involving Mr **REDACTED** I sentence you to a term of imprisonment of sixteen months to date from 24 January 2012 and to expire on 23 May 2013.

In relation to count 2 on the first indictment, the count involving Mr  , I sentence you to a term of imprisonment of sixteen months to date from 24 February 2012 and to expire on 23 June 2013.

In relation to count 4 on the first indictment, the count involving Mr **REDACTED** **REDACTED** I sentence you to a term of imprisonment of sixteen months to date from 24 March 2012 and to expire on 23 July 2013.

In relation to count 5 on the first indictment, the count involving Mr **REDACTED** I sentence you to a term of imprisonment of sixteen months to date from 24 April 2012 and to expire on 23 August 2013.

In relation to count 6 on the first indictment, the count involving Mr  , I sentence you to a term of imprisonment of sixteen months to date from 24 May 2012 and to expire on 23 September 2013.

In relation to count 7 on the first indictment, the count involving Mr  I sentence you to a term of imprisonment of sixteen months to date from 24 June 2012 and to expire on 23 October 2013.

In relation to count 8 on the first indictment, a count involving Mr  , I sentence you to a term of imprisonment of sixteen months to date from 24

July 2012 and to expire on 23 November 2013.

In relation to count 9 on the first indictment, the count involving Mr

AWB, I sentence you to a term of imprisonment of sixteen months to date from 24 August 2012 and to expire on 23 December 2013.

In relation to count 10 on the first indictment, the count involving Mr

AWB, I sentence you to a term of imprisonment of sixteen months to date from 24 September 2012 and to expire on 23 January 2014.

In relation to count 4 on the second indictment, the count involving Mr

REDACTED, and taking into account the four matters on the Form 1, I sentence you to a term of imprisonment of seventeen months to date from 24 October 2012 and to expire on 23 March 2014.

In relation to count 11 on the first indictment the count involving Mr

AWC, I sentence you to a term of imprisonment of thirty-one months to date from 24 November 2012 and to expire on 23 June 2015.

I set a non-parole period of eighteen months.

The total effect of sentence remains as one of four years with a non-parole period of eighteen months. You are eligible to be considered for release to parole on 23 December 2012. The total sentence will expire on 23 June 2015.

I find special circumstances.

I have not changed the total sentence, I just had to structure things differently. I will have my associate give you copies of what I have just read. The significant change is just to the last count, the sentence imposed for the last count.

Yes is there anything that either of you wishes to raise?

BELLANTO: Your Honour mentioned the last count, but there are changes on

HER HONOUR: Yes, not to the actual sentences imposed, but to the accumulation. But I've changed the sentence in relation to count 11 to reflect the principle of totality. Mr Crown is there a problem?

SKINNER: No your Honour, I hadn't totally taken it all in but I understand what you're saying.

HER HONOUR: Yes, if there's a problem let me know.

SKINNER: No it's just the numbers your Honour, I understand the rest of it but I'm in the middle of a trial and I'm a bit slow this morning.

HER HONOUR: Yes well if there's a problem, I'm in the middle of a trial too, but let me know some time during the day, but I've checked them as many times as I can.

SKINNER: I'm sure there wouldn't be your Honour, I just can't give you the assurance with the accumulative based on the accumulative it should be that's all.
