ANTECEDENT

The defendant receives a disability pension. He works part-time as a bus driver. The defendant is also a soccer referee

FULL FACTS

The alleged offences occurred between March 1996, and October, 1996. At the time of the offences the victim was 8 years of age. The defendant was the victim's soccer coach at the REDACTED. On the 23 November, 1999 The Joint Investigation Team at Liverpool received a notification in relation to the victim. The victim had passed a note to a school friend stating that she had been raped by the defendant when she was in year 3. This note was found by a School Teacher. On the 8 February, 2000 the victim was interviewed by staff from the Joint Investigation Team, where she made a number of disclosures about being sexually assaulted by the defendant. OFFENCE ONE- SEXUAL INTERCOURSE WITH CHILD UNDER 10. Between March and October, 1996, Approximately one month after meeting the POI, the victim was staying over at the defendant's house at REDACTED. REDACTED The defendant's de facto, REDACTED was also at the location. It is alleged that the victim was sitting on the defendant's bed between the defendant and REDACTED. It is alleged that the defendant began touching the victim on the vagina on the outside of her clothing. This lasted for approximately 5 minutes. The victim states that she fell asleep and woke up a short time later as the defendant was lying on top of her. At this time the victim felt something being pushed into her vagina. The victim states that as a result of this her vagina was hurting and she was struggling, but could not move due to the weight of the defendant. The victim asked the defendant if she could go to toilet at which time the defendant got off her and she left the room, returning to the spare room to sleep. OFFENCE TWO- SEXUAL INTERCOURSE WITH CHILD UNDER 10 Years. Between March and October, 1996, the victim was again staying over at the defendant's home. Also staying at the house were the defendant's two younger children. It is alleged that one night the victim was asleep in the spare room, when REDACTED came into the room and told her that the defendant wanted to see her. The victim walked to the defendant's bedroom in a sleepy state and lay down on the bed beside him and then fell asleep. The victim woke up a short time later and found the POI lying on top of her. The victim stated that she could feel the defendant's hand near her vagina, holding onto his penis. The

POI then put his penis inside the victim's vagina. The victim states that REDACTED walked out of the room and returned about 5 minutes later, where the defenant was still sexually assaulting the victim. The victim stated that her vagina was stinging and was particularly painful when she went to the toilet. It is unknown whether the POI ejaculated. OFFENCE THREE- SEXUAL INTERCOURSE WITH CHILD UNDER 10 YEARS. Between March and October 1996, the victim was staying over at the defendant's with her cousin REDACTED REDACTED who was aged 10 years at the time. It is alleged that REDACTED and the victim had just gone to bed when the defendant walked into the spare room. The defendant said "Good Night" to the girls and then got into bed with the victim. The defendant has then put his penis in the victim's vagina. The victim began to cry and REDACTED said "Why is she crying." The defendant stated that the victim was just missing her mum. The defendant has then got off the victim and walked over to REDACTED, who has asked him to turn off the electric blanket. The defendant has then left the room. On the 12 July, 2000 the defendant attended Bankstown Police Station where he was arrested, cautioned and interviewed in relation to these allegations. The defendant denied all three allegations. The defendant was then charged with the matters now before the court.
