The Commission for Children and Young People is responsible for promoting the well being of children and young people in NSW.

This responsibility includes monitoring organisations and individuals who work with children to make sure they are meeting their obligations under the NSW Working With Children Check (the Check). These obligations are set out in the *Commission for Children and Young People Act 1998* (the Act).

The Commission is currently contacting organisations and individuals that provide tutoring to children, including dance tuition. Your business has been identified as providing this type of service to children. However, our records show that RG Dance is not registered for the Check, nor has a Certificate for Self Employed People in Child-Related Employment been issued in the name of Grant Davies. It could be that you are registered under a different name, or that you have not registered or applied for the Certificate because you think the Act does not apply to you. Please confirm that either you intend to comply with your legal obligations or the reason why they do not relate to you or your organisation. You can do this by e-mailing your response to **REDACTED** no later than 29 June 2012.
