students about his sexuality. Mr STEWART was never my teacher, but I remember him. He was openly gay and this was common knowledge between the students. He was flamboyant and spoke with a lisp. I remember that he used to tell the students to tuck their shirt in. He would say words to the effect "Tuck your shirt in or I will tuck it in for you."

5. Mr Craig TRELOAR, I did not know as a teacher. He was respected and again was strict and disciplined the students. Mr TRELOAR was a boarding master. He was in charge of my boarding area, Gilmore House in year six and seven. Mr TRELOAR would often discipline the students. Mr TRELOAR would say words to the effect of. "Touch your toes" or "spread your cheeks" Mr TRELOAR would use his foot to kick you on the back side. He would often do this in view of other students and was not hidden. I was known to TRELOAR on a first name basis and had quite a good relationship with him. Mr TRELOAR would alternate doing night duties with other masters. I recall Mr TRELOAR having some favourite students, their names were REDACTED, ATF _____ and ARD _____. These were not close friends of mine. I remember on occasions Mr TRELOAR showed me pornographic videos. This was known between the student, however not spoken about in depth. I believe it was some sort of escalation of dares to watch these videos with Mr TRELOAR. Students knew it was happening. I don't remember how I got involved or any conversation that surrounded how I was first introduced to watching pornographic videos with Mr TRELOAR. I knew of others that had watched pornographic video, however we did not speak about it. I remember in about year six and seven. I had a girlfriend. I would write her letters. I started to write letters with a sexual nature that was often read out aloud to other students. I started to write stories with an explicit sexual nature and would use my girlfriend as a character. I would ask Mr TRELOAR to proof read them. I would speak about these stories and was not shy and would often get attention for this behaviour. I think there was about half a dozen of these letters and stories. I do not remember if these stories were as a result of the pornographic videos watched or created as imagination.
6. On one occasion, It was either in year six or seven I was watching pornographic videos in Mr TRELOARS private room. It was possibly in the afternoon after school. I do not remember what I was wearing, however I remember my pants had a fly. I can't recall how I came to be in the room. Whether I was invited or conversation surrounding the circumstances. I distinctly remember the content of the videos. The first one was a male and a female. The female was dressed as a French maid. I remember she was wearing provocative clothing and was trying o

get the attention of the man when she was cleaning. To get his attention she straddled the male and they began to have sex. The male then began to have oral sex on the female. The second video was two males throwing a Frisbee in the park. I believe it was about a 1970's video because of the clothing they were wearing. A female ran in the park and the males tried to get her attention. The males purposely went in her direction to get her attention. The males then had sex with this female. They also performed oral sex with this female. The third video was of two males in a room. One of the males left and the other male brought a female cleaner in the room. The female performed oral sex on the male. The other male then brought back two females. The cleaner left the room, whilst the one of the males had sex with the two females. The cleaner watched from the outside through the key hole. The cleaner was then invited back into the room. There was then five persons in the room. They were all involved in sexual acts. I believe we watched these videos for about half an hour. Mr TRELOAR and I were the only ones in the room. Whilst I was watching these videos there was some sort of conversation. I do not remember the exact conversation. I remember some sort of escalation to talking about masturbation. I remember Mr TRELAOR stating that he did not believe that I would be able to ejaculate. Whilst I was sitting on the coach, Mr TRELOAR sat on the bed. I had a doona over me. I remember starting to masturbate. I do not remember the conversation. I remember ejaculating on the doona. I then showed Mr TRELAOR the semen that remained on the doona. He did not any stage see me naked or touch me. He said words to the effect of "you can." He showed surprise and admiration that I had ejaculated. I do not remember the circumstances of leaving after this or any conversation. I told my girlfriend, REDACTED about this incident when I was about in my early twenties. I later told another girlfriend, REDACTED about this incident when I was about 25 years of age.

7. When I was in year eight I had a friend named ARN. We stayed together in the same boarding dorm. He was in the bed next to mine. On one night we had decided to swap beds. This was because during the day Mr FOTIS had said to him "Im gonna get you tonight." ARN took this seriously and was why he wished to swap beds. I remember saying that I would sleep there as if I could handle him. I remember when I was asleep a cool breeze went over my legs. I can recall a hand touching my leg and sliding up my lower leg. I was half a sleep. It was dark at the time however could see due to street lighting. ARN had jumped, and standing on his bed as he was also awoken. I recall him calling something out. It was dark enough that I could not see who did this. Someone turned the light on and this person that

touched my leg had grabbed ARN's doona off the bed and put it over his head. I believe it was an adult due to his height. This person then ran out of the room and down the highway. All the boarders were awoken and a number of students chased this person with a doona down the street. This made quite a scene and soon about sixty students were awake and wondering what was going on. There was always rumours that this person was FOTIS, however not too sure. I remember that all the parents were aware of this incident, including my parents.

8. Mr FOTIS was my football coach. He gave most of the students a weird vibe. During training he would often tackle you and wrestle with you longer than necessary. For this reason all the players never wanted to be chosen to be tackled by Mr FOTIS.

9. Mr NISBETT was the boarding master of Kooyong house. In about year eleven or twelve he asked me to feed the sheep on occasions. On one of these occasions a friend, REDACTED REDACTED and I attended his house or residence near the boarding house. I took a friend as I was not comfortable going by myself. I was aware that I was not supposed to be there at this time. There were no other students or masters during this time. In his residence we were allowed to go through his private stuff. We had found a firearm that we were allowed to handle. This was an heirloom for his father or grandfather. I found it strange that we were allowed to play with it. It was as if we were allowed this freedom and he would not report our bad behaviour because this was not common place for students to be in a master's private residence. We would not say anything because we would get in trouble for our behaviour.

10. I contacted my parents after certain incidents regarding teachers from Knox Grammar had been reported in the media. I spoke to my mother and told her of the above incidents. I had not previously told her. She was aware of the incident with the doona, however did not know anything else. I contacted the police in relation to making a statement. I had not heard of any other incidents with other students. I had an isolated incident with Mr TRLOAR and didn't feel the need to report the incident to police.
