## NEW SOUTH WALES

On 13 July 2011, the Director of Public Prosecutions on behalf of Her Majesty charges that

CDM

1. Between 1 October 2008 and 10 November 2010 at REDACTED in the State of New South Wales indecently assaulted CEW, a child then of the age of two, three or four years.  
Section s61M(2) Crimes Act 1900  
Law Part Code: 291 / 67803

**AND the Director of Public Prosecutions FURTHER CHARGES in the alternative that**

2. Between 1 October 2008 and 10 November 2010 at REDACTED in the State of New South Wales indecently assaulted CEW in circumstances of aggravation, namely that the said CEW REDACTED was then under the authority of the said CDM.  
Section s61M(1) Crimes Act 1900  
Law Part Code: 290

**AND the Director of Public Prosecutions FURTHER CHARGES that**

CDM

3. Between 1 October 2008 and 12 November 2010 at REDACTED in the State of New South Wales indecently assaulted CEY, a child then of the age of three, four or five years.  
Section s61M(2) Crimes Act 1900  
Law Part Code: 291 / 67803

**AND the Director of Public Prosecutions FURTHER CHARGES in the alternative that**

4. Between 1 October 2008 and 12 November 2010 at REDACTED in the State of New South Wales indecently assaulted CEY in circumstances of aggravation, namely that the said CEY REDACTED was then under the authority of the said CDM

*Section s61M(1) Crimes Act 1900*

**Law Part Code: 290**

**AND the Director of Public Prosecutions FURTHER CHARGES that**

CDM

5. Between 1 October 2008 and 10 November 2010 at REDACTED in the State of New South Wales indecently assaulted CDO a child then of the age of one, two or three 3 years.  
*Section s61M(2) Crimes Act 1900*  
**Law Part Code: 291 / 67803**

**AND the Director of Public Prosecutions FURTHER CHARGES in the alternative that**

6. Between 1 October 2008 and 10 November 2010 at REDACTED in the State of New South Wales indecently assaulted CDO in circumstances of aggravation, namely that the said CDO was then under the authority of the said CDM
