Dear Carolyn

I have received a **NOTICE OF INTENTION TO IMPOSE CONDITIONS ON CHILDRENS SERVICE LICENSE** from Jennifer Mason. This was dated 15/11/2010.

I am writing to you because I do not wish to have all of these condition placed on my license based on the following:

CDM appeared in Kogarah court on 1 December 2010. Although the hearing was adjourned until 21 December 2010, his bail conditions were reduced dramatically and we would like these to be reflected in the conditions you do place on our license.

His bail conditions now allow him to attend CEG on Saturdays and/or Sundays (when no children are on the premises) to carry out maintenance and repairs. We pride ourselves on our immaculate building, play areas and resources and do not want our standards to fall while this matter is resolved.

Please note that CDM will be supervised during these visits by myself, CHD

I feel that it is essential that CDM continues with the upkeep of the centre to ensure that the building, playground and all equipment remains in it's current high quality condition therefore ensuring a safe environment for the children, staff and their families. CDM has been the sole maintenance person since 1st October 2010 and I have huge confidence in him with this role.

Could you kindly consider making amend to the **PROPOSED LICENSE CONDITIONS** on page 1 of the **NOTICE OF INTENTION TO IMPOSE CONDITIONS ON CHILDRENS SERVICE LICENSE** allowing restricted access to the service?

Also can you kindly amend the **REASONS FOR ISSUING THIS NOTICE** on page 2. Under point (d) bail is subject to the following conditions:

- (i) he is to report daily to Sutherland Police Station between the hours of 8am-8pm.
Please note: He only ever had to report Mondays and Fridays and this has now been dropped to Mondays only.
- (iv) he is not to approach or have contact with any parent, child or staff member of the service
Please note: he is now allowed to have contact with all staff.
- (vi) he is not to approach the service
Pleaser note: he is now allowed to approach the centre on weekends.

I am attaching a copy of recent bail conditions for you and please contact me if you require any further information. I will inform you of any outcomes from the next hearing on 21 December 2010.
