

INDICTMENT

NEW SOUTH WALES

On 10th February 2005, the Director of Public Prosecutions on behalf of Her Majesty charges that

VICTOR MAKAROV

1. Between 5 July 1997 and 10 July 1997 at Camperdown in the State of New South Wales, in circumstances of aggravation, did assault and at the time of that assault did commit an act of indecency on the said , he being then under the age of 16 years, namely 14 years.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

2. Between 5 July 1997 and 10 July 1997 at Camperdown in the State of New South Wales, in circumstances of aggravation, did assault and at the time of that assault did commit an act of indecency on the said , he being then under the age of 16 years, namely 14 years.

VICTOR MAKAROV

3. Between 5 July 1997 and 10 July 1997 at Camperdown in the State of New South Wales, had sexual intercourse with , he being a person between the ages 10 and 16 years, namely 14 years of age and under the authority of the said VICTOR MAKAROV.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

4. Between 13 July 1997 and 19 July 1997 at Camperdown in the State of New South Wales, in circumstances of aggravation, did assault

and at the time of that assault, did commit an act of indecency on the said BZY [REDACTED], he being then under the age of 16 years, namely 14 years.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

5. Between 13 July 1997 and 19 July 1997 at Camperdown in the State of New South Wales, being the teacher of BZY [REDACTED], a boy of or above the age of 10 years and under the age of 18 years, namely 14 years, had homosexual intercourse with him.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

6. Between 13 July 1997 and 19 July 1997 at Camperdown in the State of New South Wales, being the teacher of BZY [REDACTED], a boy of or above the age of 10 years and under the age of 18 years, namely 14 years, had homosexual intercourse with him.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

7. Between 13 July 1997 and 19 July 1997 at Camperdown in the State of New South Wales had sexual intercourse with BZY [REDACTED], he being a person above the age of 10 years and under the age of 16 years, namely 14 years, and under the authority of the said VICTOR MAKAROV.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

8. Between 13 July 1997 and 19 July 1997 at Camperdown in the State of New South Wales, being the teacher of BZY [REDACTED], a boy of or above the age of 10 years and under the age of 18 years, namely 14 years, had homosexual intercourse with him.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

9. Between 20 October 1999 and 1 August 2000 at Gladesville in the State of New South Wales, being the teacher of [BZY], a boy of or above the age of 10 years and under the age of 18 years, namely 16 or 17 years, had homosexual intercourse with him.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

10. Between 3 July 1998 and 3 January 1999 at Surry Hills in the State of New South Wales, being the teacher of [BZX], a boy of or above the age of 10 years and under the age of 18 years, namely 16 years, had homosexual intercourse with him.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

11. Between 3 July 1998 and 3 January 1999 at Epping in the State of New South Wales, did commit an act of gross indecency with [BZX], a person under the age of 18 years, namely 16 years.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

12. Between 20 August 1999 and 18 May 2000 at Gladesville in the State of New South Wales, being the teacher of [BZX], a boy of or above the age of 10 years and under the age of 18 years, namely 17 years, had homosexual intercourse with him.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

13. Between 20 August 1999 and 18 May 2000 at Gladesville in the State of New South Wales, being the teacher of [BZX], a boy of or above the age of 10 years and under the age of 18 years, namely 17 years, had homosexual intercourse with him.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

14. Between 3 July 1998 and 31 October 1998 at Epping in the State of New South Wales, being the teacher of [BZW] a boy of or above the age of 10 years and under the age of 18 years, namely 13 or 14 years, had homosexual intercourse with him.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

15. Between 3 July 1998 and 3 January 1999 at Epping in the State of New South Wales, in circumstances of aggravation, did assault [BZW] [BZW] and at the time of that assault did commit an act of indecency on [BZW], he being then under the age of 16 years, namely 13 or 14 years.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

16. Between 3 July 1998 and 3 January 1999 at Surry Hills in the State of New South Wales, in circumstances of aggravation, did assault [BZW] [BZW] and at the time of that assault did commit an act of indecency on [BZW], he being then under the age of 16 years, namely 13 or 14 years.

AND The Director Of Public Prosecutions FURTHER CHARGES that

VICTOR MAKAROV

19. Between 19 August 1999 and 1 August 2000 at Gladesville in the State of New South Wales, being the teacher of BZW, a boy of or above the age of 10 years and under the age of 18 years, namely 15 years, had homosexual intercourse with him.
