STATEMENT OF A WITNESS

In the matter of: Police -v- Andrew McIntosh
 Place: Hornsby Police Station
 Date: 21 May, 2009

Name: Sasha CHANDLER.

STATES:

1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false, or do not believe to be true.
2. I am 34 years of age.
3. About 3pm on the 11th of October 2006, I conducted an interview on audio and video tapes at Hornsby Police station Detective Johnston and Ellis. The interview was in respect to my statement made to Police in relation to Andrew McIntosh.
4. Throughout this statement, I made reference to a four day Camp at Towlers Bay around June 1992. Whilst I was at this camp I saw that most of the Cadets set up in various spots of Pittwater. At the completion of general activities for the evening on the first day, Andrew McIntosh would take me to his house via a boat. This boat was his boat that I made reference to in my previous statement. Despite the fact that McIntosh knew that I was uncomfortable being removed from the other cadets and being taken across to his house he would instruct me to co-operate and get in his boat. He said words similar to, "We are going back to Towlers Bay tonight". I would suggest to him that I wanted to stay but he would just say, "Chandler get in the boat".
5. On the first night of this Cadet Camp, I remember I got into his boat, this was just on dark. We travelled about 20 min across Pittwater to his Towler's Bay property. Andy made me sleep in his bed with him. He would take me to his house and instruct me to get my clothes off. This was done in his bedroom at his property as previous on occasions. As per other instances in the past he would climb into the bed naked also. He would start playing with my genitals and instruct me to do the same to him. He would then put KY type gel between my legs and make me lie face down. He would then place his erect penis between my legs as would simulate sexual intercourse with his Penis between my legs. Every time he did this he would allow his penis to penetrate my anus. He would claim that this was an accident and would remove his penis immediately having had it penetrate approximately 3cm. I was absolutely horrified when this happened and he would just laugh it off. At the time I could feel the head of his penis go into my anus. When this would happen I would flinch and try and pull away. It hurt so much that I would scream with shock and it would hurt a lot. This would go on for about 15 minutes until he would ejaculate. He would then play with my genitals, and as I was 17 years old, I got an erection. He would then make me put my penis between his legs. He instructed me to do this until I ejaculated also. After this he would make me shower with him. Whilst this occurred he would wash me down again washing my genitals and anus and his. It would seem that he was washing away semen from us both. After this he would allow me to go to sleep.



6. Upon waking the next morning we returned to the camp site by his boat, where the rest of the students were including my brother. When I returned I felt inside that I was deliberately ostracised. I thought people would know what was going on.
7. On the second night I distinctly remember McIntosh told me we had a mobile phone installation to do in a car for someone. This was an attraction because I thought I may be able to earn some money from it. I thought this was normal and would not involve any sexual assault. When we got on his boat and made our way to his house I then realised that he was lying and we were going straight back to his house at Towlers Bay. This feeling was of horror and desperation as I realised we were going back to his house again. When we got to his house, he again instructed me to take my clothes off and get in his bed. He would take all his clothes off and lay down beside me. As per the previous time he would place KY gel around my anus and between my legs and begin to push his penis in and out of between my legs. Again he would push his penis against my anus where I could feel the end of his penis penetrate my anus by about 3cm. Again this really hurt me and I would flinch every time. When he finished he would then make me do the same to him until I ejaculated. He would then tell me to get in the shower, whereby he would wash me down and was my genitals and anus area. We then went to sleep in his bed.

8. The next morning, we went back to the cadet's camp as per usual. Again I felt ostracised and left out of the main group. We continued this day of activities.
9. On the third night I realised it was probably going to be the same occurrence. I felt a feeling of desperation not to go. But I felt that I had no choice. Again around the same time approaching darkness he took me to his house again. On the third night, there was the same occurrence. He would penetrate my anus and between my legs with his penis until he ejaculated. He would then make me do the same to him. On each occasion he would penetrate me by about 3cm. I knew this as it really hurt my anus and it was an unnatural feeling. When this was finished he again washed us down in the shower and we would go to bed in his house.
10. On the fourth night the same occurrences unfolded, He would tell me we were going to his house again. We travelled there via his boat. When we got there he would instruct me to take my clothes off as he did. He would then put KY gel on and around my anus and between my legs and begin to motion and penetrate my anus by about 3cm. Again it hurt a lot and it would be a real shock to me. This I can remember distinctly, each time. After he did that to me, he then made me do it to him. Then after this he would take us to the shower and wash us both down, washing semen off us. We then later went to bed.
11. On the morning of the fifth day, we returned to the camp. Each day the camp moved. It finished at the World War 2 bunkers (fortified positions) in the Ku-ring-gai national park head land. On this day the camp finished and upon completion, awards were given out. I received a 'zippo lighter' from McIntosh for helping with the planning the camp. I remember on the last day, we had a tactical exercise through the bunkers.
