STATEMENT OF A WITNESS

In the matter of: HISTORICAL CHILD SEXUAL ASSAULT - BARKER COLLEGE

STATES:

1. This statement made by me accurately sets out the evidence that I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I will be liable to prosecution if I have wilfully stated in it anything that I know to be false, or do not believe to be true.
2. I am 31 years of age.
3. I was a student at Barker College 91 Pacific Hwy Hornsby in infants in the mid 80's and then returned to the college in year 7 in 1988. I became part of the Barker Cadet Unit in year 8 in 1989 where I met Andrew MCINTOSH who was a Lieutenant of the cadet unit and in charge of the specialist unit and in a position of authority over 350 students. In 1990 (year 9) and now 14 years of age I joined the specialist unit officially and promoted to the rank of Corporal. Andrew MCINTOSH began to single me out and often publicly ridiculed me. There he would make me sit out and keep me back to discuss my behaviour and then console me with physical embraces at times.
4. In 1991 now aged 15 years I was taken down to Church Point by Andrew and then we boarded a small boat to Towlers Bay. You had to take a boat as the place was not accessible by road. I remember the absolute fear I was about to face. Andrew had told me I had done something bad and I required punishment. He made me strip naked and get on all fours on the lounge room floor. He hit me with a belt about 10 times. Later we left to go back to Church Point to get some videos and came back to the house at Towlers Bay to watch them. The videos were 'R' rated. Andrew proceeded to masturbate me and then insisted I reciprocate. I ejaculated very shortly afterwards as he did. There were no further sexual acts committed that evening.
5. On other occasions my friends [REDACTED] was with me at Towers Bay when both of us were subjected to physical and sexual abuse from Andrew. There were so many incidents that I don't remember the exact dates but I remember the incidents.
6. On occasions while we were at Towers Bay Andrew showed me all the different firearms he had and let me fire them across the bay and also we used them in the context of the cadet unit.
7. The sexual, mental and emotional abuse happened up to 2 -3 times a week and continued until 1992 but I still had contact with him up until 1994.
8. [REDACTED] was aware of the physical abuse that had happened to me over the years but he was not aware of the sexual assaults from Andrew until I told him. My brother [REDACTED] was also aware of the physical abuse by Andrew but it wasn't until the year 2000 that I told him I had been sexually assaulted by Andrew for all those years.

- 9. In 1997 I spoke to MCINTOSH by phone when I was in England and he ended up saying to me. "Don't you worry Mr CHANDLER; I know where you live, and where your family is and exactly what you are doing." The last time he was seen was about April 2006 at the Crows Nest Pub playing the pokies and has been seen there quite often. He was seen by my brother REDACTED
- 10. The information I have given is only a very abbreviated account of the verbal, physical and sexually abuse I suffered at the hands of Andrew.
- 11. I know that this happened many years ago but I felt I had to come and report this now because I am still in so much fear of him and what he has done to me. I am also in fear of the repercussions of what he will do to me and my family with all the threats he made to me and his retaliation against me if I revealed what he did to me. I have further concerns that he is still committing these horrible acts on other children. I felt it necessary to come to the police with this matter.
