## NEW SOUTH WALES

On \_\_\_\_\_ 2015, the Director of Public Prosecutions on behalf of Her Majesty charges that

### GRANT WILLIAM DAVIES

1. Between 8 November 2002 and 1 July 2003 at Five Dock in the State of New South Wales did have sexual intercourse with [BZI \_\_\_\_\_] without her consent, knowing that she was not consenting to the sexual intercourse, in circumstances of aggravation, namely that at the time [BZI \_\_\_\_\_] was under the age of 16 years, namely 12 years.

*Section 61J(1) Crimes Act 1900*

**AND the Director of Public Prosecutions FURTHER CHARGES that**

### GRANT WILLIAM DAVIES

2. Between 8 November 2002 and 1 July 2003 at Five Dock in the State of New South Wales did assault [BZI \_\_\_\_\_] and at the time of such assault committed an act of indecency on [BZI \_\_\_\_\_] [BZI \_\_\_\_\_], in circumstances of aggravation, namely that at the time [BZI \_\_\_\_\_] was under the age of 16 years, namely 12 years.

19. Between 29 October 2010 and 17 May 2013 at Sydney in the State of New South Wales did cause or procure [BZF], a child under 14 years, namely 11, 12 and 13 years, to be used for the production of child abuse material.

**GRANT WILLIAM DAVIES**

20. Between 20 October 2010 and 10 April 2013 at Sydney in the State of New South Wales did produce child abuse material.

**AND the Director of Public Prosecutions FURTHER CHARGES that**

**GRANT WILLIAM DAVIES**

21. Between 31 December 2011 and 1 February 2012 at Chiswick in the State of New South Wales did assault [BZF] and at the time of such assault committed an act of indecency on [BZF] [BZF] a person then under the age of 16 years, namely 12 years.

25. On or about 1 March 2012 at Sydney in the State of New South Wales did commit an act of indecency towards BZG [redacted] a person under the age of 16 years, namely 11 years, in circumstances of aggravation, namely that at the time BZG [redacted] was under the authority of Grant William DAVIES.

26. Between 2 April 2013 and 10 April 2013 at Sydney in the State of New South Wales, being an adult, did engage in conduct that exposed indecent material to REDACTED [redacted] being a child then under 14 years, namely 12 years, with the intention of making it easier to procure the child for unlawful sexual activity with himself .
