2. Between 31st January 1984 and 6th December 1984 at Hunters Hill in the State of New South Wales did assault ^{CDR} [redacted] and at the time of such assault did commit an act of indecency upon ^{CDR} [redacted]

12. Between 28th January 1985 and 25th April 1985 at Hunters Hill in the State of New South Wales did assault CFC [redacted] and at the time of such assault did commit an act of indecency upon CFC [redacted]

AND THE DIRECTOR OF PUBLIC PROSECUTIONS FURTHER CHARGES THAT**John Dennis MAGUIRE**

13. Between 28th January 1985 and 15th August 1985 at Hunters Hill in the State of New South Wales did assault CFC [redacted] and at the time of such assault did commit an act of indecency upon CFC [redacted]

AND THE DIRECTOR OF PUBLIC PROSECUTIONS FURTHER CHARGES THAT

14. Between the 31st day of January 1984 and the 6th day of December 1984, at Hunters Hill in the State of New South Wales, did assault ^{CFD} [REDACTED] an at the time of the assault, committed an act of indecency on ^{CFD} [REDACTED]

AND THE DIRECTOR OF PUBLIC PROSECUTIONS FURTHER CHARGES THAT

John Dennis MAGUIRE

15. Between 31 January 1984 and 6 December 1984, at Hunters Hill in the State of New South Wales, did assault ^{CFD} [REDACTED] and at the time of the assault, committed an act of indecency on ^{CFD} [REDACTED]

AND THE DIRECTOR OF PUBLIC PROSECUTIONS FURTHER CHARGES THAT

John Dennis MAGUIRE

16. That John Dennis Maguire, between 31 January 1983 and 31 December 1983, on the Pacific Highway between Newcastle and Sydney, in the State of New South Wales, did commit an act of indecency towards ^{CFE} [REDACTED] a person then under the age of 16, being 12 years of age.
