I asked ^{CDN} about ^{CDO} seeing a psychologist and she said that ^{CDO} had been interviewed at Sutherland CSC, and had also been interviewed by the psych. ^{CDN} said that the psych would have asked her similar questions to the ones that were asked in the JIRT interview. I asked about the outcome of the psych interview, and she said that she was not happy with the environment in which this had occurred and said that ^{CDO} had not disclosed anything and they did not see a need for her to see them again.
