File Note: 09/02/2011, 15:30- Phone call to CDP [REDACTED] CDP [REDACTED] stated that CDQ is now attending [REDACTED] at [REDACTED] from Tuesdays to Thursdays and she is settling in well.

CDP [REDACTED] stated that Kelly spoke to her about what CDQ [REDACTED] disclosed in her interview and that she didn't want to talk. CDP [REDACTED] also stated that Kelly mentioned we would make a referral for protective behaviour counselling for CDQ. CDP [REDACTED] said that she was very keen for this as she was very concerned about CDQ. CDP [REDACTED] said that she always taught CDQ about her to protect herself, who was allowed to touch her Eric and she was very concerned that someone was able to get behind that defence and abuse CDQ. I stated that I would make a referral to Sydney Children's CPU for counselling for herself and CDQ [REDACTED].

CDP [REDACTED] stated that she is separated from CDQ's father [REDACTED] [REDACTED] [REDACTED] is aware of what CDQ [REDACTED] disclosed and the investigation but she hasn't told him what happened today yet as he is overseas. CDP [REDACTED] said that [REDACTED] was initially reluctant for CDQ [REDACTED] to be interviewed, but it was a joint decision to allow CDQ [REDACTED] to be interviewed. CDP [REDACTED] said that her and [REDACTED] are going through the courts at the moment so their relationship is a bit strained but he is supportive of CDQ getting help. CDP [REDACTED] stated that she would contact [REDACTED] and let him know what happened today and about the counselling referral and it would be up to [REDACTED] how much he participated.

CDP [REDACTED] said that she has another son [REDACTED] who is 7. CDP [REDACTED] stated that [REDACTED] doesn't know what has happened with CDQ [REDACTED] but will have to tell him eventually. I stated that it may be best for her to talk to the counsellor about the best way to do this. CDP [REDACTED] agreed.
